



## May Your Holidays be Filled with Joy Not Scams

Be vigilant! The holidays present a prime opportunity for fraudsters to imposter legitimate businesses and organizations to gain access to financial data. Unfortunately, these scammers may also target tax return information. To guide taxpayers in navigating a recent tax scam, where scammers impersonated the DRS by sending a fraudulent text message, DRS issued **Taxpayer Services Special Bulletin 2025-6**, *Taxpayer Alert DRS Warns Taxpayers of New Scam Involving Fraudulent Text Messages*.

## **HOLIDAY TAX MATTERS**

#### 'Tis the Season for Festive Shopping!

While strolling through holiday fairs, browsing charming holiday shops, or supporting local retail establishments, keep in mind that sales and use tax is likely to apply to the sale of holiday purchases. The sales and use tax charged should be separately stated by the retailer on the sales receipt. Speaking of receipts, remember it's a good idea to keep those sales receipts for any holiday returns!

#### Need to Return a Gift?



Keep in mind that sales and use tax does not apply to any portion of the amount charged for items returned within 90 days from the date of purchase.

**Save Yourself Time by Purchasing Gift Cards!** The sales of gift cards are not subject to sales and use taxes. However, when a gift card is used to purchase an item or service, the purchase of such item or service may be subject to sales and use taxes.

A Clean Chimney Keeps the Holiday Magic Flowing! As you get ready for those cold winter nights, keep in mind that chimney sweeping services and other services to get your home sparking for the holidays may be subject to sales and use taxes.

A Toasty Home Will Keep You Cheery and Bright This Holiday Season! As the weather gets chilly and the



holiday spirit fills the air, here's some good news to keep you warm and toasty! The sale of firewood is not subject to sales and use taxes when it is purchased for residential heating or domestic cooking—perfect for warming your home or roasting chestnuts by the fire.

More to cheer about! Delivery fees in connection with firewood purchased for residential heating are also tax free!

**Keep Those Aching Backs at Bay!** As you get ready to keep your driveway clear and your holidays hassle-free, don't forget—snow removal services are subject to Connecticut sales and use taxes. All persons performing snow removal services are required to register and obtain a Sales and Use Tax Permit with DRS.

## **COZYING UP TO THE 2026 TAX FILING SEASON**

Did you know that combining e-filing with direct deposit is the quickest way to get your refund? Did you also know that electronic filing offers taxpayers who have a return with a balance due, the option of filing early and selecting a date to pay the tax on any date or before April 15? Another benefit of electronically filing your return, is that you will receive an acknowledgment of receipt from DRS and your return will be verified as mathematically correct, eliminating data entry errors.
