If there is balance due, you will be prompted to make a payment before submitting the return. You can pay with ACH Debit/Direct Payment or Credit Card, or you can Pay After Filing. Select the payment method and click Next.

Select Payment Method ACH Debit/Direct Payment Select this option to make a payment with this return. The direct payment option allows you to transfer funds by authorizing the Department of Revenue Services and its designated Financial Agents to electronically debit your bank account for the amount of your tax payment. Credit Card Make a credit card payment at the ACI Payments, Inc. website. **Credit Card payments are subject to a convenience fee. Credit cards accepted include American Express, Discover, MasterCard, and Visa. After your return has been submitted, you will be provided with a button to link to ACI Payments, Inc. to 'Make a Credit Card Payment' **A convenience fee will be charged by the credit card service provider. The convenience fee is generally 2.35% of the payment amount, with a minimum charge of \$3.95. You will be informed of the amount of the fee and may elect to cancel the transaction. At the end of the transaction, you will be given a confirmation number for your records. The estimated convenience fee that will be charged is \$4.88 ACH Credit/Pay After Filing Selecting this payment option does not automatically initiate your payment. The confirmation number you will receive with this return only acknowledges the filing of the return. You must initiate a payment separate to this filing. Only those taxpayers who are currently registered for and who already pay by ACH credit may use this option.




