30 Client Lobbyists Selected for 2026 Audit by Office of State Ethics

Hartford – For the 2026 audit cycle, 40 client lobbyists were chosen at random from all client lobbyists (see background) registered at any time between January 1, 2023, and December 31, 2025. The first 30 drawn who were not subject to an audit in the previous three years comprise the final list, which is below.

The Office of State Ethics will contact each selected lobbyist with information about the audit process.

Connecticut's lobbying laws help prevent corruption and promote public trust by ensuring that citizens have transparent access to information about who is spending money to influence state government, the issues being targeted, and the activities supported by those expenditures.

The list of selected lobbyists will be posted on the Ethics website at ct.gov/ethics.

BACKGROUND

A client lobbyist is the entity that pays for lobbying services on its behalf and expends, or agrees to expend, \$3,000 or more on lobbying in a calendar year. A communicator lobbyist is the individual who is paid to lobby for the client. As part of each client lobbyist audit, Ethics will also audit all associated communicator lobbyists.

The Office of State Ethics conducts its annual Audit Lottery during the CEAB's November regular meeting. As with all CEAB meetings, the lottery is open to the public, including members of the lobbying community and the media. Interested individuals may attend in person or join remotely.

The lottery and subsequent audits are core components of the Office of State Ethics' oversight responsibilities and reinforce transparency and accountability within Connecticut's lobbying community.
