CLIENT REGISTRANT

REGISTER on **ETH-1B** form on or before January 15, or before commencing lobbying activity (whichever is later).

Financial Disclosure Filings on **ETH-2D** form (Due quarterly)

(ALSO due monthly while CT General Assembly is in regular session AND when the client registrant expends or agrees to expend \$100+ for legislative lobbying)

COMMUNICATOR REGISTRANT

REGISTRATION

- **ETH-1A** form
- In House Communicators register on client's **ETH-1B** form

(Register on or before January 15, or before commencing lobbying activity (whichever is later).

FINANCIAL DISCLOSURE

- **ETH 2A** form

(Due Jan 10 annually)

ADDITIONAL FORMS

- **ETH-2B** form: for communicators who make unreimbursed expenditures of \$10 or more for the benefit of a public official or their staff or immediate family (file according to client's filing calendar, i.e., monthly or quarterly)
- **ETH-2C** form: for communicators who are registered to lobby for a municipality or subdivision thereof (file according to client's filing calendar, i.e., monthly or quarterly)
