By notice dated April 22, 2022, the Commission informed the parties that the continued hearing would take place on May 18, 2022.

Approximately one hour before the May 18 continued hearing was scheduled to begin, the complainants filed a motion to postpone the hearing. In the motion, the complainants represented that they had an unexpected medical emergency. The complainants further stated that, "[i]f a continuance can be granted, we would appreciate that. If not, we understand, and will refile the complaint as necessary. . . . " The motion has been marked as Complainants' Post-Hearing Ex. M.

Due to the fact that this matter is scheduled to expire on June 30, 2022, the undersigned hearing officer denied the complainants' motion.

The hearing officer notes that Attorney Nicholas R. Bamonte, counsel for the respondents, appeared at the continued hearing with Chief of Police Edwin Henion. The complainants did not appear to prosecute the complaint.

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:
