The above-captioned matter was scheduled to be heard as a contested case on June 8, 2021. Due to the COVID-19 pandemic and the state's response to it, the June 8, 2021 hearing was conducted via videoconference. Absent objection from the respondents, the hearing officer granted the complainant's request.

On October 24, 2022, a continued in-person hearing convened, at which time the complainant and the respondents appeared. However, the complainant requested that the hearing be continued because he was not prepared to proceed at that time. Absent objection from the respondents, the hearing officer granted the complainant's request.

On January 31, 2023, a continued in-person hearing was scheduled to convene. The respondents appeared, with a witness, but the complainant failed to appear.

The following order is hereby recommended on the basis of the record concerning the above-captioned complaint:

1. The complaint is dismissed for failure to prosecute.
