The above-captioned matter was heard as a contested case on May 14, 2024, at which time the complainant and the respondents appeared and presented testimony, exhibits, and argument on the complaint. The complainant, who is incarcerated, appeared via teleconference pursuant to the January 2004 memorandum of understanding between the Commission and the Department of Correction. See *Anthony Sinchak v. Freedom of Information Commission*, Docket No. HHD-CV03-0826293, Superior Court, J.D. of Hartford at Hartford, Corrected Order dated January 27, 2004 (Sheldon, J.).

At the hearing, the respondents testified that they sent copies of all records they maintain that were responsive to the request to the Department of Correction, in accordance with §1-210(c), G.S.<sup>1</sup> After such testimony, the complainant withdrew the complaint on the record.


The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

1. Based on the withdrawal, the complaint is dismissed.

<sup>1</sup> Section 1-210(c), G.S. provides: "Whenever a public agency receives a request from any person confined in a correctional institution ... for disclosure of any public record under the Freedom of Information Act, the public agency shall promptly notify the Commissioner of Correction ... before complying with the request as required by the Freedom of Information Act. If the commissioner believes the requested record is exempt from disclosure pursuant to [§1-210(b)(18), G.S.], the commissioner may withhold such record from such person when the record is delivered to the person's correctional institution ...."


