The above-captioned matter was heard as a contested case on August 13, 2024, at which time the respondents appeared, but the complainant did not appear due to an illness. A continued hearing was held on October 11, 2024 at which time the complainant and respondents appeared and presented testimony, exhibits and argument on the complaint. The complainant who is incarcerated, appeared via teleconference, pursuant to the January 2004 memorandum of understanding between the Commission and the Department of Corrections. See Docket No. CV 03-0826293, Anthony Sinchak v. FOIC et al, Superior Court, J.D. of Hartford at Hartford, Corrected Order dated January 27, 2004 (Sheldon, J.)

After consideration of the entire record, the following facts are found and conclusions of law are reached.

- 1. The respondents are public agencies within the meaning of §1-200(1), G.S.
- 2. It is found that on November 17, 2023, the complainant submitted two requests¹ to the respondents seeking copies of investigative reports, interviews, and statements given by LaDean Daniels to any Hartford Police Detective, active or retired concerning James Raynor/Kendel Jules² regarding Hartford police case numbers 09-31298 and 09-31423. The scope of both November 17 requests included but was not limited to: (i) police detective investigative notes; (ii) written statements; (iii) arrest warrants, if any; (iv) uniform arrest reports; (v) documented interviews; and (vi) informant case/file numbers, if any.

² The complainant's November 17 requests were nearly identical except one request (Complainant's Exhibit A) sought reports, interviews and statements concerning James Raynor, and the other request (Complainant's Exhibit B) sought reports, interviews, and statements concerning Kendel Jules.

- 3. It is found that the respondents received the complainant's November 17 requests on November 27, 2023, and acknowledged their receipt of such requests by letter to the complainant, dated November 29, 2023.
- 4. By letter of complaint received and filed on December 7, 2023, the complainant appealed to this Commission alleging that the respondents violated the Freedom of Information ("FOI") Act by failing to comply with his November 17 requests described in paragraph 2, above.
 - 5. Section 1-200(5), G.S., provides:

"[p]ublic records or files" means any recorded data or information relating to the conduct of the public's business prepared, owned, used, received or retained by a public agency, or to which a public agency is entitled to receive a copy by law or contract under section 1-218, whether such data or information be handwritten, typed, tape-recorded, videotaped, printed, photostated, photographed or recorded by any other method.

6. Section 1-210(a), G.S., provides in relevant part that:

[e]xcept as otherwise provided by any federal law or state statute, all records maintained or kept on file by any public agency, whether or not such records are required by any law or by any rule or regulation, shall be public records and every person shall have the right to . . . (3) receive a copy of such records in accordance with section 1-212.

- 7. Section 1-212(a), G.S., provides in relevant part that "[a]ny person applying in writing shall receive, promptly upon request, a plain, facsimile, electronic or certified copy of any public record."
- 8. It is concluded that the records described in paragraph 2, above, to the extent that they exist and are maintained by the respondents are public records within the meaning of §§1-200(5) and 1-210(a), G.S.
- 9. It is found that by letter dated June 7, 2024, the respondents informed the complainant of the following:
 - a. they had identified 45 pages of records responsive to his request related to case # 09-31423;

- b. a portion of the records identified as responsive to his request for case #09-31423 had been redacted pursuant to §§1-210(b)(3)(A) and 1-216,³ G.S., as well as Federal Code 28 CFR Part 23;
- c. to obtain a copy of the 45 pages identified by the respondents, the complainant should either mail the respondents payment of \$22.50, or request a waiver of such fees by filing an affidavit of indigence;⁴ and
- d. the "Cold Case Unit (Office of the Chief State's Attorney) had previously assumed the investigation of case #09-31423. As a result, the Cold Case Unit has possession of the initial case file and all current records pertaining to the investigation."
- 10. It is further found that in their June 7 letter, the respondents also informed the complainant that records related to case #09-31298 were no longer maintained, as the ten-year retention period for such records had elapsed.

Case Number 09-31298

- 11. With respect to records related to case #09-31298, the complainant asserts that the ten-year retention period should not have elapsed, because that case related to his arrest in January 2014 as well as his co-defendant's arrest in 2015/2016.
- 12. While under cross-examination, however, the complainant testified, and it is found that both case numbers at issue in this matter involve incidents occurring in 2009. It is further found that such case numbers did not include information concerning the subsequent arrests of the complainant and his co-defendant in 2014 and 2015/2016, respectively.
- 13. It is found that records relating to case #09-31298 were subject to a ten-year retention period in accordance with the Office of Public Records Administrator's records retention schedule and were destroyed on November 3, 2021. See Respondents' Exhibit 6.
- 14. Accordingly, it is found that no responsive records for case #09-31298 existed at the time of the complainant's November 17 requests.
- 15. It is concluded, therefore, that the respondents did not violate the disclosure provisions of §§1-210(a) and 1-212(a), G.S., with respect to the records requested for case #09-31298.

⁴ Per <u>Respondents' Exhibit 3</u>, the respondents sent the communications described in paragraphs 9 and 10, above, to the complainant through the Department of Corrections ("DOC"). Attached to the letter to the complainant in <u>Respondents' Exhibit 3</u>, was a letter addressed to DOC staff indicating "[e]nclosed is a final response letter to a Freedom of Information request, which the Hartford Police Department received from Inmate James Raynor. Please forward the enclosed letter and identified records to Inmate Raynor for review should you see fit."

Case Number 09-31423

16. With respect to records related to case #09-31423, the complainant maintains that the respondents did not provide all records responsive to his requests.

Records Maintained by the Respondents

- 17. It is found that case #09-31423, despite relating to events that occurred in 2009, was not subject to the respondents' 10-year retention period as such case pertained to a homicide investigation.
- 18. It is found that prior to their receipt of the complainant's November 17 requests, the respondents transferred the entire case file for case #09-31423 to the Cold Case Unit of the Connecticut State Division of Criminal Justice (the "Cold Case Unit").
- 19. It is found that despite transferring the case file for #09-31423 to the Cold Case Unit, the respondents retained copies of some records concerning such case.
- 20. It is found that the respondents searched their records and identified 45 pages of records responsive to the complainant's November 17 requests.
- 21. It is found that any other records relating to case #09-31423 existing at the time of the complainant's November 17 request were physically stored by the Cold Case Unit.
- 22. The respondents contend that because they transferred the file for case #09-31423 to the Cold Case Unit, they no longer physically maintained such records, and thus were under no obligation to provide them to the complainant.
- 23. As noted in paragraph 6, above, §1-210(a), G.S., subjects all records maintained or kept on file by a public agency to disclosure under the FOI Act.
- 24. In <u>Town of Avon v. Sastre</u>, 2022 WL 6421446, at *4 (Sep. 20, 2022), aff'd, 224 Conn. App. 15 (October 19, 2023) (hereinafter <u>"Sastre"</u>), the Court interpreted the phrase "maintained or kept on file' in §1-210(a) as meaning within the possession, custody or control of the public agency."
- 25. In Docket #FIC 2022-0550, <u>Ian Cooke v. Commissioner</u>, <u>State of Connecticut Department of Emergency Services and Public Protection et al.</u> (Nov. 15, 2023) ("Cooke"), the Commission considered whether the Department of Emergency Services and Public Protection ("DESPP") "maintained" their own employees' personnel files despite the fact that such files were stored by DAS pursuant to a Memorandum of Understanding which stated that DAS would provide Human Resources services for DESPP.
- 26. Applying <u>Sastre</u> to the facts in <u>Cooke</u>, the Commission found that DESPP "maintained" their employees' personnel files within the meaning of §1-210(a), G.S. Specifically, the Commission found that DESPP exercised control over the records and was: (i) able to access such records; (ii) decide what information to redact from such records; and (iii) provide copies of such records directly to the complainant.

- 27. With respect to the records transferred to the Cold Case Unit, it is found that as the records originated from the respondents, they would be able to decide what information to redact from such records. The respondents' ability to determine what information to redact is further evidenced by the fact that they were able to make redactions to those portions of case #09-31423 disclosed to the complainant on June 7, 2024.
- 28. It is found that the respondents provided no evidence concerning their ability to access the records from the Cold Case Unit and disclose copies of such records directly to the complainant. The only evidence the respondents provided as to the interaction between the Cold Case Unit and local police departments (generally) is a printout from the Connecticut Division of Criminal Justice's website, which has been marked as Respondents' Exhibit 1.
- 29. It is found that nothing in <u>Respondents' Exhibit 1</u> suggests that the respondents lose access to records transferred to the Cold Case Unit. In fact, as described in <u>Respondents' Exhibit 1</u>, the Cold Case Unit appears to work collaboratively with local police departments, to solve cold cases. ⁵
- 30. It is found that the respondents could have, but did not, request that the Cold Case Unit provide them with records responsive to the complainant's November 17 requests. It is found that in doing so, the respondents would have been able to provide copies of such records directly to the complainant.
- 31. It is found that the respondents failed to prove that they did not maintain any other records responsive to the complainant's November 17 requests, besides those that were disclosed to the complainant on June 7, 2024, as indicated in paragraph 35, below.
- 32. Moreover, it is found that by not requesting records responsive to the complainant's November 17 requests from the Cold Case Unit, the respondents did not conduct a diligent and thorough search for such records. Accordingly, it is found that the respondents failed to prove that they disclosed all records responsive to the complainant's November 17 requests.
- 33. It is concluded, therefore, that the respondents violated the disclosure provisions of §§1-210(a) and 1-212(a), G.S., with respect to the records transferred to the Cold Case Unit.

Records Provided to the Complainant and Redactions Made Thereto

34. As noted in paragraph 9, above, on June 7, 2024, the respondents informed the complainant via letter⁶ that they had identified 45 pages of records responsive to his November 17 requests, and that "[t]o *obtain* a copy of the records *identified* as being in possession of the Hartford Police Department, please mail a \$22.50 payment to: [respondents' mailing address] Alternatively, you may . . . [c]omplete the enclosed Affidavit of Indigence. . . ." (Emphasis added).

⁵The respondents have also failed to cite *any* statutory or judicial authority indicating that local police agencies lose their ability to access records once they are transferred to the Cold Case Unit. The Commission, in its research, has found no authority on the issue.

- 35. At the October 11, 2024 hearing, however, the respondents testified, and it is found, that they had *provided* the 45 pages of identified records to the Department of Corrections (the "DOC") to forward to the complainant as part of the their June 7, 2024 letter to the DOC and the complainant⁷ in response to the complainant's November 17 requests.⁸
- 36. As noted in paragraph 9, above, as part of their June 7 production, the respondents redacted certain portions of the 45 pages of responsive records, citing §§1-210(b)(3)(A) and 1-216, G.S., as well as Federal Code 28 CFR Part 23 as their basis for doing so.

Commission's Jurisdiction to Review Exemptions Claimed as Part of the Respondents' June 7 Production

- 37. At the October 11, 2024 hearing and in subsequent correspondence with the Commission, the respondents have taken the position that "no. . .in camera review [of the redacted portions of the June 7 production] is material or necessary in this case, given that Mr. Raynor admitted that he never paid for copies of documents and never provided the Respondents with an affidavit of indigency. As a result, the respondents were never under an obligation to release any documents to Mr. Raynor."
- 38. Although it is unclear whether the respondents claim that §1-212(c), G.S., limits the Commission's jurisdiction to review the records disclosed to the complainant and adjudicate the exemptions claimed therein, the Commission will address such claim herein.
- 39. Section §1-212(c), G.S., provides, in relevant part that "[a] public agency *may* require the *prepayment* of any fee required or permitted under the Freedom of Information Act if such fee is estimated to be ten dollars or more." (Emphasis added.)
- 40. As the Supreme Court has observed, "the use of the term 'may' ordinarily does not connote a command. Rather, the word generally imports permissive conduct and the conferral of discretion." <u>DiLieto v. County Obstetrics and Gynecology Group, P.C.</u> 310 Conn. 38, 47-48 (2013) (Citations omitted, ellipses omitted, internal quotation marks omitted).

Respondents' Exhibit 5 in this matter. As part of offering those records into evidence, the respondents sent copies of their proposed exhibits to the complainant via the DOC on August 8, 2024. The differences between the letter identified in paragraph 34, above, and the respondents' testimony referenced in paragraph 35, above, coupled with the fact that the respondents had sent the same records to the complainant as a proposed exhibit created ambiguity as to: (i) when the complainant first received the 45 pages of records responsive to his November 17 requests and (ii) whether he received those records as part of the respondents' response to his November 17 requests or as part of correspondence regarding the proposed exhibits the respondents planned to offer at the hearing in this matter. This ambiguity, in part, formed the basis of the Third Order for Additional Evidence dated November 4, 2024. In complying with that order, the respondents submitted an Affidavit of Detective William Diaz dated November 7, 2024, which clarified that "[o]n June 7, 2024, the Respondents produced to Mr. Raynor c/o Stephane Secore of the Department of Corrections, forty-five (45) pages of documents (Respondents' Exhibit 5). . . ." Such affidavit is in evidence as Respondents' Exhibit 8 (After-Filed).

⁹ The respondents did not claim §1-216, G.S., as an exemption at either the contested case hearing on this matter, or on the In Camera Index submitted pursuant to an order of the Hearing Officer, dated October 11, 2024.

- 41. There is no indication in the plain language of §1-212(c), G.S., that the legislature intended the word "may" as used therein to carry any other meaning other than importing permissive conduct and the conferral of discretion.
- 42. Moreover, §1-212(c), G.S., does not define the term "prepayment." Nevertheless, there is no indication that the legislature intended any other meaning besides the common dictionary definition when using the word "prepayment." ¹⁰
- 43. It is found that as defined by Merriam-Webster, the word "prepay" is a verb that means "to pay or pay the charge on in advance." It is further found that "prepayment" is a noun identifying an arrangement wherein a payment is made in advance.¹¹
- 44. Using the plain meaning of the words "may" and "prepayment" as identified in paragraphs 40 through 43, above, §1-212(c), G.S., provides public agencies with the discretion to require that a requestor pay for records in advance of receiving such records. This discretion is only limited by the requirement that the estimated fees for such records would exceed ten dollars.
- 45. As found in paragraph 34, above, the respondents, in their June 7 letter informed the complainant that: (i) the fees for records contained therein amounted to \$22.50 and (ii) he needed to remit payment or submit an affidavit of indigency.
- 46. Nevertheless, as found in paragraph 35, above, the respondents provided the 45 pages of responsive records *contemporaneously*¹² with their June 7 letter informing the complainant of the fees for the records (i.e., the June 7 production).
- 47. It is found that because the respondents provided the records to the complainant at the same time they requested he remit payment or submit an affidavit of indigency, the respondents did not actually seek "prepayment" within the meaning of §1-212(c), G.S.
- 48. In addition, the respondents cite Docket #FIC 2010-497, <u>Kacey Lewis v. Chief</u>, <u>Police Department</u>, <u>City of Waterbury et al.</u> (June 22, 2011) (hereinafter, <u>"Lewis"</u>), and Docket #FIC 2018-0574, <u>Jean Conquistador v. Chief</u>, <u>Police Department City of Meriden et al.</u> (September 11, 2019) (hereinafter <u>"Conquistador"</u>) to support their position that in camera review of the records of the June 7 production is neither "material or necessary in this case." Neither case is on point.
- 49. In <u>Lewis</u>, the Commission considered whether the respondents in that case failed to act promptly by not providing records until fees were paid. The Commission concluded that §1-

¹² <u>See</u> "Contemporaneous," <u>Merriam-Webster, https://www.merriam-webster.com/dictionary/contemporaneous</u> (accessed November 8, 2024) (defining "contemporaneous" as meaning existing, occurring, or originating at the same time.")

- 212(c), G.S., "does not require an agency to deliver copies of records prior to receiving payment." <u>Lewis</u> differs from the instant case as the respondents in <u>Lewis</u> exercised their right under §1-212(c), G.S., to withhold records until the associated fees were paid.
- 50. Similarly, in <u>Conquistador</u>, the Commission considered whether the respondents in that case violated §§1-210(a) or 1-212(a), G.S., by withholding records until the complainant paid the associated fees or demonstrated that he was indigent at the time of the request. The Commission held that they did not. As in <u>Lewis</u>, the facts in <u>Conquistador</u> are entirely distinguishable, because the respondents therein exercised their right under §1-212(c), G.S., to withhold records until fees were paid or the complainant could demonstrate his indigency.
- 51. It is found that the respondents in this case could have, but did not, withhold records from the complainant until such time that the complainant paid the associated fees or demonstrated his indigency.
- 52. It is found that the respondents exercised the discretion afforded to them pursuant to §1-212(c), G.S., and in doing so, chose to forgo requiring the *prepayment* of fees.
- 53. The respondents' choice not to withhold records from the complainant under §1-212(c), G.S., has no bearing on the Commission's jurisdiction to adjudicate any exemption claimed therein and does not obviate the need for in camera inspection of such records disclosed to the complainant.
- 54. Moreover, the respondents' interpretation of §1-212(c), G.S., as set forth in paragraph 37, above, contradicts the fundamental principle that, "[w]e must interpret the statute so that it does not lead to absurd or unworkable results." See Wilkins v. Connecticut Childbirth and Women's Center, 314 Conn. 709, 723 (2014) (Citations omitted; internal quotation marks omitted). Accepting the respondents' interpretation of §1-212(c), G.S., effectively creates a mechanism by which public agencies may choose not to exercise their right to seek prepayment of fees in order to avoid the Commission's review of claimed exemptions.
- 55. It is concluded, therefore, that the records sent to the complainant as part of the respondents' June 7 production and any exemptions claimed therein are within the Commission's subject matter jurisdiction.¹³

Records Submitted for In Camera Inspection

56. Pursuant to an order of the Hearing Officer dated October 11, 2024, the respondents submitted responsive records to the Commission for in camera inspection along with an Index of Records Submitted for In Camera Inspection ("In Camera Index"). The in camera records consist of 46 pages and are hereinafter referred to as IC 2023-0632-001 through IC 2023-0632-046.

¹³ Nothing herein suggests that the respondents have forfeited their right to collect the \$22.50 in fees from the complainant. While the respondents are entitled to such fees, the Commission is not deprived of its ability to adjudicate claimed exemptions for records that were disclosed in response to a request for records under the FOI Act. The respondents may have other available avenues to collect the outstanding fees.

- 57. The respondents made a substantial number of redactions, too numerous to individually list herein. Accordingly, the respondents' In Camera Index, setting forth the pages and line numbers of the respondents' claimed exemptions is annexed hereto as Appendix A.
- 58. On their In Camera Index, the respondents cite the following statutes as a basis for their claimed exemptions: §§53a-129a, G.S., 54-142a, G.S., 42-470, G.S., 42-471(c), G.S., 1-215(b)(1), G.S., 1-210(b)(3)(A), G.S., 1-210(b)(3)(H), G.S., and 28 CFR Part 23.
- 59. At the October 11, 2024 hearing, the complainant indicated that he was not seeking any birth dates or social security numbers that were redacted by the respondents. Accordingly, the Commission will not consider the following redactions:
 - a. IC 2023-0632-001 lines 6, 7, 8, 10, and 12;
 - b. IC 2023-0632-003 lines 15 (word 14)¹⁴, 16 (word 9), 17 (words 5 and 15)
 - c. IC 2023-0632-009 line 20 (word 10)
 - d. IC 2023-0632-024 lines 15 (word 14), 16 (word 9), 17 (words 5 and 15)
 - e. IC 2023-0632-030 line 20 (word 10)
 - f. IC 2023-0632-041 line 6 (the "date of birth" box)
 - g. IC 2023-0632-045 line 4 (under the "date of birth" column), 5 (under the "date of birth" column), 15 (word 14)
- 60. On their In Camera Index, the respondents indicated that IC 2023-0632-043 was inadvertently included in the disclosure to the complainant and was not responsive to his request. Upon careful inspection of IC 2023-0632-043 it is found that such record does not correspond to either case number referenced in the complainant's November 17 requests, is not responsive to those requests, and will not be considered further by the Commission.
- 61. The respondents maintain that the in camera records set forth in Appendix B are exempt from disclosure pursuant to §1-215(b)(1), G.S.
- 62. Section 1-215, G.S., pertains to records of arrests, which are defined therein to include:

the name, race and address of the person arrested, the date, time and place of the arrest, and the offense for which the person was arrested, and . . . in addition a case in which (A) the arrest has been made by warrant the arrest application, including any affidavit in support of such warrant, or (B) the arrest was made without a warrant, the official arrest, incident or similar report, provided if a judicial

¹⁴ The Hearing Officer used the number of each word on a line to identify the specific redactions made by the respondents. Dates following the format xx/xx/xxxx, xx/xx/xx, xx-xx-xxxx or similar will be considered a single word. Paragraph numbers were not counted as words.

authority has ordered any such affidavit or report sealed from public inspection or disclosure, in whole or in part, the portion of the affidavit or report that has not been sealed, if applicable, as well as a report setting forth a summary of the circumstances that led to the arrest of the person in a matter that does not violate such order. "Record of arrest" does not include any record of arrest of a juvenile, a record erased pursuant to chapter 961a, or any investigative file of a law enforcement agency compiled in connection with the investigation of a crime resulting in an arrest.

63. Section 1-215(b)(1), G.S., states, in relevant part, that:

Notwithstanding any provision of the general statutes, and except as otherwise provided in this section, any record of the arrest of any person shall be a public record from the time of such arrest and shall be disclosed in accordance with the provisions of section 1-212 and subsection (a) of section 1-210. No law enforcement agency shall redact any record of the arrest of any person, except for (1) the identity of witnesses. . . .

- 64. Those portions of the in camera records which the respondents claim are exempt pursuant to §1-215(b)(1), G.S., are identified in Appendix B, annexed hereto. Upon careful inspection of the in camera records, it is found that those portions of the in camera records identified in Appendix B consist of either arrest warrant face sheets or arrest warrant applications containing affidavits which constitute a "record of arrest" within the meaning of §1-215, G.S.
- 65. Moreover, it is found that those portions of the in camera records identified in Appendix B reveal either: (i) the names of witnesses or (ii) other information from which the identity of a witness may be ascertained (e.g., a residential address or Department of Corrections location). Accordingly, it is found that such information is permissively exempt from disclosure pursuant to §1-215(b)(1), G.S.
- 66. It is concluded, therefore, that the respondents did not violate the disclosure provisions of $\S1-210(a)$ and 1-212, G.S., by redacting those portions of the in camera records identified in Appendix B.¹⁵
- 67. The respondents next claim that the following portions of the in camera records are exempt from disclosure pursuant to §54-142a, G.S.:
 - a. IC 2023-0632-001 line 14 (boxes labeled "Charge 1" and "Charge 2")
 - b. IC 2023-0632-012 lines 8 (word 11) and 15 (word 5)

¹⁵ All portions of the in camera records claimed by the respondents as exempt pursuant to §§1-210(b)(3) and 53a-129a, G.S., and 28 CFR 23 are permissively exempt from disclosure under §1-215(b)(1), G.S. Accordingly, the Commission need not consider such exemptions raised by the respondents.

- c. IC 2023-0632-018 lines 36 (words 14 and 15) and 37 (up to the word "in")
- d. IC 2023-0632-019 lines 8 (box labeled "Count One Did commit the offense of:") and 9 (box labeled "In violation of General Statutes number")
- e. IC 2023-0632-024 line 14 (box labeled "Charge 1")
- f. IC 2023-0632-033 line 8 (word 11) and 15 (word 2)
- g. IC 2023-0632-039 line 36 (words 14-15)
- h. IC 2023-0632-041 lines 8 (box labeled "Count One Did commit the offense of:") and 9 (box labeled "In violation of General Statutes number")
- 68. Section 54-142a, G.S., provides in relevant part:
 - (a) Whenever in any criminal case . . . the accused, by a final judgement, is found not guilty or the charge is dismissed, all police and court records of any state's attorney pertaining to such charge shall be erased upon the expiration of the time to file a writ of error or take an appeal, if an appeal is not taken, or upon final determination of the appeal sustaining a finding of not guilty or a dismissal, if an appeal is taken.

. . .

- (c)(1) Whenever any charge in a criminal case *has been nolled in the Superior Court*, or in the Court of Common Pleas, if at least thirteen months have elapsed since such nolle, all police and court records and records of the state's prosecuting attorney or the prosecuting grand juror pertaining to such charge shall be erased. . . .
- (2) Whenever any charge in a criminal case has been continued at the request of the prosecuting attorney, and a period of thirteen months has elapsed since the granting of such a continuance during which period there has been no prosecution or other disposition of the matter, the charge shall be nolled upon motion of the arrested person and such erasure may thereafter be effected or a petition filed therefore, as the case may be, as provided in this subsection for nolled cases.

(Emphasis added).

- 69. It is found that the respondents did not provide any evidence as to whether the portions of the in camera records identified in paragraph 67, above, contain charges wherein either: (i) "the accused, by a final judgement, is found not guilty or the charge is dismissed. . .[;]" or (ii) "ha[d] been nolled in the Superior Court."
- 70. It is found that the only evidence the respondents provided regarding §54-142a, G.S., was that the in camera records identified in paragraph 67, above, were redacted because prosecutors removed and/or substituted the charges contained therein. However, §54-142a, G.S., does not apply to charges that were removed or substituted by prosecutors.
- 71. Moreover, upon careful inspection of the in camera records identified in paragraph 67, above, such records do not, on their face, establish the applicability of §54-142a, G.S.
- 72. It is concluded, therefore, that the respondents violated the disclosure provisions of §§1-210(a) and 1-212(a), G.S., by redacting those portions of the in camera records identified in paragraph 67, above.
- 73. Last, the respondents claim that IC 2023-0632-022 line 12 (box labeled "Master File No.") is exempt from disclosure pursuant to §42-471(c), G.S.
 - 74. Section 42-471(c), G.S. provides as follows:

As used in this section, (1) "personal information" means information capable of being associated with a particular individual through one or more identifiers, including, but not limited to, a Social Security number, a driver's license number, a state identification card number, an account number, a credit card or debit card number, a passport number, an alien registration number, a health insurance identification number, or any military identification information, and does not include publicly available information that is lawfully made available to the general public from federal, state or local government records or widely distributed media, and (2) "military identification information" means information identifying a person as a member of the armed forces, as defined in section 27-103, or a veteran, as defined in said section, including, but not limited to, a selective service number, military identification number, discharge document, military identification card or military retiree identification card.

75. While the respondents claim that the master file number redacted at IC 2023-0632-022 – line 12 is exempt from disclosure pursuant to §42-471(c), G.S., it is found that the

respondents did not provide evidence to establish the applicability of §42-471(c), G.S., to the master file number listed on an arrest warrant face sheet.

- 76. Accordingly, it is found that the respondents failed to prove that IC 2023-0632-022 line 12 is exempt from disclosure pursuant to §42-471(c), G.S.
- 77. It is concluded, therefore, that the respondents violated the disclosure provisions of §§1-210(a) and 1-212(a), G.S., by redacting IC 2023-0632-022 line 12 (box labeled "Master File No.").

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

- 1. Within seven (7) days of the Notice of Final Decision in this matter, the respondents shall: (i) provide the complainant with copies of those records identified in paragraphs 67 and 73 of the findings, above, unredacted and free of charge and (ii) request from the Cold Case Unit records (or copies thereof) for case #09-031423 that are responsive to the complainant's November 17 requests.
- 2. Within forty-five (45) days of the Notice of Final Decision in this matter, the respondents shall provide the complainant with copies of all records received by the respondents from the Cold Case Unit pursuant to paragraph 1 of this order, above.
- 3. In complying with paragraph 2 of this order, above, the respondents: (i) need not provide duplicates of records already disclosed to the complainant, except as provided for in paragraph 1 of this order, above; and (ii) may redact only those portions of the responsive records, if any, that are mandatorily exempt from disclosure. The respondents may not redact any information that is permissively exempt from disclosure. The respondents shall provide such records to the complainant free of charge. If, pursuant to this order, the respondents withhold any record that is subject to a mandatory exemption, they shall submit an affidavit to the Commission (with copy to the complainant) sworn to or attested by a person with the requisite knowledge, and detailing the types of records withheld and the statutory basis for withholding such records.
- 4. If the respondents are unable to retrieve responsive records (or copies thereof) from the Cold Case Unit within the time prescribed in paragraph 2, above, the respondents shall submit an affidavit to the Commission (with copy to the complainant) attested to by a person with the requisite knowledge, explaining the reason for their inability to retrieve such records.
- 5. Since the respondents received FOI Act training by Commission staff subsequent to the hearings and prior to the Commission issuing this final decision, no training is required at this time.
- 6. Henceforth, the respondents shall strictly comply with the disclosure provisions in §§1-210(a) and 1-212(a), G.S.
