The Commissioners voted 7-0 to approve the Petition for Reconsideration dated December 3, 2024 and received by the Commission on December 3, 2024, filed by Respondents in *David Cummings v. Chief Court Administrator, State of Connecticut, Judicial Branch; and State of Connecticut, Judicial Branch*, Docket #FIC 2023-0633. The Commissioners voted 7-0 to remand the matter to the Hearing Officer. Commissioner Fuzesi was not present for the votes.

Attorney C. Zack Hyde reported on the Superior Court decision dated December 5, 2024, in <u>Aviva Stahl</u>; <u>Seth Wessler v. FOIC and DOC</u>, Docket No. HHB-CV23-6077479-S. The Court upheld the Commission's final decision in Docket # FIC 2021-0697, *Aviva Stahl and Seth Wessler v. Commissioner, State of Connecticut, Department of Correction; and State of Connecticut, Department of Correction.* The Commissioners took no action.

The Commissioners voted 7-0 to approve the filing of a Joint Motion for Remand in Bridgeport Police Department, et al. v. Freedom of Information Commission, AC47762 on the

condition that: the Commission's agreement to file the Joint Motion to Remand is based on the unique facts and circumstances of the instant case and is not intended to provide any precedential value to the procedures set forth in such Motion; and it does not constitute a concession regarding the process by which exemptions to disclosure are to be raised and proven by respondent agencies appearing before it, as such agencies must raise exemptions to disclosure during the contested case hearing on the underlying matter and must provide detailed evidence proving the applicability of such exemptions to the records at issue, so that the Commission can properly hear and decide the contested case within the timeframes required by law. Commissioner Fuzesi was not present for the vote.
