The above-captioned matter was scheduled to be heard as a contested case on March 4, 2025 at which time the respondents appeared, with a witness, but the complainant did not. Prior to commencing the March 4 hearing, the undersigned Hearing Officer discovered an error in the file which resulted in the complainant not receiving notice for the hearing. Accordingly, the undersigned hearing officer continued the hearing.


A rescheduled hearing in this matter was scheduled to be heard on April 24, 2025, at which the respondents appeared, with a witness, but the complainant did not. Three minutes before the April 24 hearing was scheduled to commence, the complainant emailed the Commission seeking to postpone the hearing for at least one month, as he had recently suffered an injury. The undersigned hearing officer continued the hearing.

A rescheduled hearing was again scheduled to be heard on July 2, 2025, at which time the respondents appeared, with a witness, but the complainant failed to appear. At the direction of the undersigned Hearing Officer, Commission staff contacted the complainant. The complainant informed the Commission that he would not be attending the scheduled hearing.

The following order is hereby recommended on the basis of the record concerning the above-captioned complaint:

1. The complaint is dismissed for failure to prosecute.


