
The above-captioned matter was scheduled to be heard as a contested case on March 20, 2025, at 2:30 pm, at which time the respondents appeared, but the complainant did not appear to prosecute the case.

The hearing officer notes that Attorney Ashley Meskill, counsel for the respondents, appeared at the hearing with one witness. Specifically, it is noted that Attorney Meskill appeared with Melissa M. Frank, Director of Insurance and Risk Management. Attorney Meskill represented that she had spent the better part of two days reviewing the file in this matter, meeting with Director Frank, and preparing for the hearing. In addition, Director Frank represented that she had spent approximately ten hours reviewing and responding to the underlying request for records in this case, meeting with counsel, and preparing for the hearing.

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

1. The complaint is hereby dismissed.
2. The complainant is admonished for his failure to appear at the hearing in this matter, which failure resulted in a waste of scarce state resources.


