The above-captioned matter was heard as a contested case on January 13, 2025, at which time the complainant and the respondents appeared, stipulated to certain facts, and presented testimony, exhibits and argument on the complaint.

After consideration of the entire record, the following facts are found and conclusions of law are reached:

1. The respondents are public agencies within the meaning of §1-200(1), G.S.
2. It is found that, by letter dated May 2, 2024, the complainant requested that the respondents provide her with copies of the following records:

4. All individuals involved in interviewing the applicants for job posting **230817-4731AR-001** Associate Retirement & Benefits Officer.

5. Provide document Office of the State Comptroller Applicant Tracking Data Chart for job posting **230509-0011AR-001** Planning Specialist.

6. Name of candidate offered and accepted the position from job posting **230509-0011AR-001** Planning Specialist.

7. Names of all applicants that applied to job posting Recruitment **230509-0011AR-001** Planning Specialist.

8. Names of all State of CT employees that applied to job posting Recruitment **230509-0011AR-001** Planning Specialist.

9. All individuals involved in interviewing the applicants for job posting **230509-0011AR-001** Planning Specialist.

10. Provide document Office of the State Comptroller Applicant Tracking Data Chart for job posting **240221-6890CL-001** Associate Retirement Examiner. If there is more than one, please provide both.

11. Name of candidate(s) offered and accepted the position from job posting **240221-6890CL-001** Associate Retirement Examiner.

12. Names of all applicants that applied to job posting Recruitment **240221-6890CL-001** Associate Retirement Examiner.

13. All individuals involved in interviewing the applicants for job posting **240221-6890CL-001** Associate Retirement Examiner.

14. Provide document Office of the State Comptroller Applicant Tracking Data Chart for job posting **230912-0011AR-001** Planning Specialist.

15. Name of candidate offered and accepted the position from job posting **230912-0011AR-001** Planning Specialist.

16. Names of all State of CT employees that applied to job posting Recruitment **230912-0011AR-001** Planning Specialist.

17. Names of all applicants that applied to job posting Recruitment **230912-0011AR-001** Planning Specialist.

18. All individuals involved in interviewing the applicants for job posting **230912-0011AR-001** Planning Specialist.

19. All Reclassifications within the Office of the State Comptroller February 1, 2023 to May 1, 2024 to include name, unit, division, and date of promotion, previous position, reclassified position and date of hire at the OSC.
20. All Associate Retirement & Benefits Officers (ARBOs) who supervise others, name; unit, division, supervisor of the ARBO and the names of the individuals that are supervised by the ARBO.
21. Any and all emails including attachments from/to/cc/bcc John Herrington containing or referencing "FAITH" from March 1, 2023 to May 1, 2024.
22. Any and all emails including attachments from/to/cc/bcc Robert Helfand containing or referencing "FAITH" from March 1, 2023 to May 1, 2024.
23. Any and all emails including attachments from/to/cc/bcc Morgan Roane containing or referencing "FAITH" from March 1, 2023 to May 1, 2024.
24. Any and all emails including attachments from/to/cc/bcc Yamuna Menon containing or referencing "FAITH" from March 11 2023 to May 1, 2024.
25. All emails between Robert Helfand and Sharon Roberts-Moore from January 1, 2024 to February 29, 2024.
26. All emails between John Herrington and Sharon Roberts-Moore from January 1, 2024 to February 29, 2024.
27. All emails from Robert Helfand to (including cc & bcc) Morgan Hilliard from March 1, 2023 to May 1, 2024.
28. All emails from Morgan Hilliard to (including cc & bcc) Robert Helfand from March 1, 2023 to May 1, 2024.
29. Any and all emails from/to/cc/bcc Morgan Roane containing or referencing "HOSTILE" from May 1, 2022 to May 1, 2024.

(Emphasis in original.)

3. It is found that, by email dated May 6, 2024, the respondents acknowledged the complainant's request.

4. It is found that, on May 17, 2024, May 31, 2024, June 14, 2024, June 21, 2024, July 17, 2024 and July 31, 2024, the respondents provided the complainant with responsive records

on a rolling basis; however, as of July 31, 2024, the respondents had not yet provided the complainant with the entirety of the responsive records to her twenty-nine separate requests.

5. It is found that, by letter dated and filed August 7, 2024, the complainant appealed to this Commission, alleging that the respondents violated the Freedom of Information ("FOI") Act by failing to provide her with the requested records, as described in paragraph 2, above.

6. Section 1-200(5), G.S., provides:

"[p]ublic records or files" means any recorded data or information relating to the conduct of the public's business prepared, owned, used, received or retained by a public agency, or to which a public agency is entitled to receive a copy by law or contract under section 1-218, whether such data or information be handwritten, typed, tape-recorded, videotaped, printed, photostated, photographed or recorded by any other method.

7. Section 1-210(a), G.S., provides in relevant part that:

[e]xcept as otherwise provided by any federal law or state statute, all records maintained or kept on file by any public agency, whether or not such records are required by any law or by any rule or regulation, shall be public records and every person shall have the right to (1) inspect such records promptly during regular office or business hours, (2) copy such records in accordance with subsection (g) of section 1-212, or (3) receive a copy of such records in accordance with section 1-212.

8. Section 1-212(a), G.S., provides in relevant part that "[a]ny person applying in writing shall receive, promptly upon request, a plain, facsimile, electronic or certified copy of any public record."

9. It is concluded that the requested records are public records within the meaning of §§1-200(5) and 1-210(a), G.S.

10. It is found that, on August 15, 2024, the respondents provided the complainant with the last installment of responsive records; thus, by the time of the hearing on this matter, the respondents had provided the complainant with seven installments of records.

11. The complainant contended, however, that the respondents improperly withheld and redacted records responsive to the following requests set forth in paragraph 2, above: 21, 22, 23, 24 and 29.

12. The respondents contended that the withheld records were exempt from disclosure pursuant to the provisions of: §§1-210(b)(1), 1-210(b)(2), 1-210(b)(4), 1-210(b)(6), 1-210(b)(10), 52-146r, and/or 5-237, G.S.

13. At the hearing on this matter, the complainant indicated that she was solely challenging the following exemptions raised by the respondents: §§1-210(b)(10)(attorney-client privilege), 52-146r, and 1-210(b)(4), G.S.¹

14. On February 24, 2025, the respondents submitted 9,723 pages of records to the Commission for in camera inspection. Such records will be referred to as IC-2024-0440-1 through IC-2024-0440-9723.

15. The General Counsel for the Office of the State Comptroller and Assistant State Comptroller appeared and testified at the hearing on this matter on behalf of the respondents.

Sections 1-210(b)(10) and 52-146r, G.S.

16. The respondents claimed that hundreds of pages of the in camera records are exempt from disclosure in their entirety pursuant to §§1-210(b)(10) and 52-146r, G.S., because such information is protected by the attorney-client privilege.

17. Section 1-210(b)(10), G.S., provides in relevant part that public agencies are not required to disclose “communications privileged by the attorney-client relationship ... or any other privilege established by the common law or the general statutes”

18. Section 52-146r(b), G.S., provides that “[i]n any civil or criminal case or proceeding or in any legislative or administrative proceeding, all confidential communications shall be privileged and a government attorney shall not disclose any such communications unless an authorized representative of the public agency consents to waive the privilege and allow disclosure.”

19. Section 52-146r(a)(2), G.S., defines “confidential communications” to mean:

all oral and written communications transmitted in confidence between a public official or employee of a public agency acting in the performance of his or her duties or within the scope of his or her employment and a government attorney relating to legal advice sought by the public agency or a public official or employee of such public agency from that attorney, and all records prepared by the government attorney in furtherance of the rendition of such legal advice.

20. In *Maxwell v. Freedom of Info. Comm’n*, 260 Conn. 143, 149 (2002), the

¹ On February 24, 2025, the respondents submitted for in camera review all responsive records that they withheld from the complainant including records withheld pursuant to various exemptions to the FOI Act not challenged by the complainant. Because the complainant had limited her challenges to certain exemptions during the hearing on this matter, the undersigned hearing officer issued a notice on May 6, 2025 stating that the in camera inspection would be limited to the records, or portions thereof, withheld pursuant to §§1-210(b)(10)(attorney-client privilege), 52-146r, and 1-210(b)(4), G.S., and if any party objected, they must inform the Commission of such objection by May 12, 2025. Neither the complainant nor the respondents filed any objection or other response to such order with the Commission.

Connecticut Supreme Court held that §52-146r, G.S., “merely codif[ies] the common law attorney-client privilege as this court previously defined it.” The Court further stated that “both the common-law and statutory privileges protect those communications between a public official or employee and an attorney that are confidential, made in the course of the professional relationship that exists between the attorney and his or her public agency client and relate to legal advice sought by the agency from the attorney.” *Id.*

21. The Supreme Court has adopted a four part test to determine whether communications are subject to the attorney-client privilege: “(1) the attorney must be acting in a professional capacity for the agency; (2) the communications must be made to the attorney by current employees or officials of the agency; (3) the communications must relate to the legal advice sought by the agency from the attorney; and (4) the communications must be made in confidence.” *Shew v. Freedom of Info. Comm’n*, 245 Conn. 149, 159 (1998). “If it is clear from the face of the records, extrinsic evidence is not required to prove the existence of the attorney-client privilege.” *Lash v. Freedom of Info. Comm’n*, 300 Conn. 511, 516-17 (2011).

22. Moreover, in Connecticut, the attorney-client privilege protects both the confidential giving of professional advice by an attorney acting in the capacity of a legal advisor to those who can act on it, as well as the giving of information to the lawyer to enable counsel to give sound and informed advice.” *PSE Consulting, Inc. v. Frank Mercede & Sons, Inc.*, 267 Conn. 279, 329 - 30 (2004).

23. The Supreme Court, however, has also recognized that “[n]ot every communication between attorney and client falls within the [attorney-client] privilege.” *Harrington v. Freedom of Info. Comm’n*, 323 Conn. 1, 14 (2016) (“*Harrington*”). In *Harrington*, the court made clear that

[t]he burden of establishing the applicability of the privilege rests with the party invoking it. . . . Any privilege there may be is not a blanket one. The limitation, in connection with this communication, frames the special relationship that must be found for each document separately considered. . . . Because the application of the attorney-client privilege tends to prevent the full disclosure of information and the true state of affairs, it is both narrowly applied and strictly construed.

Harrington, at 12.

24. Upon careful in camera inspection, it is found that the in camera records, or portions thereof, identified in Appendix A to this decision are communications “between a public official or employee of a public agency acting in the performance of his or her duties or within the scope of his or her employment and a government attorney,” which “relate to legal advice” sought by the public agency client from the attorney, which were “transmitted in confidence,” or were

“records prepared by the government attorney in furtherance of the rendition of such legal advice,” within the meaning of §52-146r(a)(2), G.S.²

25. It is concluded that the records, or portions thereof, identified in Appendix A to this decision constitute communications or records protected by the attorney-client privilege, within the meaning of §1-210(b)(10), G.S. It is also found that the attorney-client privilege has not been waived with respect to such records. Accordingly, it is further concluded that the respondents did not violate the disclosure provisions of §§1-210(a) and 1-212(a), G.S., when they declined to disclose a copy of such records, or portions thereof, to the complainant.

26. After careful in camera inspection, it is found that the in camera records, or portions thereof, identified in Appendix B to this decision, on the face of the records, failed to meet one or more of the criteria for the attorney-client privilege outlined in paragraphs 18 and 19, above. It is found that most of such records were comprised of communications with the complainant and/or other third parties, or did not relate to legal advice.

27. It is therefore concluded that the in camera records described in Appendix B to this decision are not exempt from disclosure pursuant to §1-210(b)(10), G.S., and the attorney-client privilege, as contended by the respondents.³

§1-210(b)(4), G.S.

28. Next, the respondents claimed that certain of the records described in Appendix B to this decision, as well as certain other in camera records, are exempt from disclosure in their entirety as strategy and negotiations relating to pending claims or litigation, pursuant to §1-210(b)(4), G.S.

29. Section §1-210(b)(4), G.S., provides that disclosure is not required of:

[r]ecords pertaining to strategy and negotiations with respect to pending claims or pending litigation to which the public agency is a party until such litigation or claim has been finally adjudicated or otherwise settled.

30. The phrase “pending claim” as defined in §1-200(8) means:

a written notice to an agency which sets forth a demand for legal relief or which asserts a legal right stating the intention to institute an action in an appropriate forum if such relief or right is not granted.

² The respondents also claimed that numerous of the in camera records described in Appendix A were exempt from disclosure pursuant to §1-210(b)(4), G.S. Since such records are exempt from disclosure pursuant to §1-210(b)(10), G.S., the Commission need not examine whether they are also exempt under §1-210(b)(4), G.S.

³ The Commission notes that the respondents, for example, claimed that 425 pages, comprised of communications between the respondents’ counsel and the complainant, were exempt from disclosure pursuant to §§1-210(b)(10) and 52-146r(a)(2), G.S., even though such communications clearly are not protected by the attorney-client privilege.

31. The phrase “pending litigation” as defined in §1-200(9) means:

(A) a written notice to an agency which sets forth a demand for legal relief or which asserts a legal right stating the intention to institute an action before a court if such relief or right is not granted by the agency; (B) the service of a complaint against an agency returnable to a court which seeks to enforce or implement legal relief or a legal right; or (C) the agency's consideration of action to enforce or implement legal relief or a legal right.

32. The Supreme Court, in *Stamford v. Freedom of Info. Comm'n*, 241 Conn. 310 (1997) (“Stamford”), cited with approval the definitions in Webster’s Third New International Dictionary of the words “strategy” and “negotiations” within the meaning of §1-210(b)(4), G.S.:

Strategy is defined as ‘the art of *devising or employing plans or stratagems*.’ [Emphasis in original] Negotiation is defined as ‘the action or process of negotiating,’ and negotiate is variously defined as: ‘to communicate or confer with another so as to arrive at the settlement of some matter: meet with another so as to arrive through discussion at some kind of agreement or compromise about something’; ‘to arrange for or bring about through conference and discussion: work out or arrive at or settle upon by meetings or agreements or compromises’; and ‘to influence successfully in a desired way by discussions and agreements or compromises.’

Stamford, at 318.

33. After careful in camera inspection of the records which are not protected by the attorney-client privilege and which the respondents also claimed are exempt from disclosure pursuant to §1-210(b)(4), G.S., it is found that IC2024-0440-1601 to IC2024-0440-1602 relate to strategy and negotiations with respect to a “claim” or “litigation,” as those terms are defined in §§1-200(8) and 1-200(9), G.S. It is found that such claim or litigation was “pending” as of May 2, 2024, the date of the request at issue in this case, as required by §1-210(b)(4), G.S.

34. It is concluded that IC2024-0440-1601 to IC2024-0440-1602 are exempt from disclosure pursuant to §1-210(b)(4), G.S. Accordingly, it is further concluded that the respondents did not violate the disclosure provisions of §§1-210(a) and 1-212(a), G.S., when they declined to disclose a copy of such records, or portions thereof, to the complainant.

35. In addition, it is found that the in camera records, or portions thereof, identified in Appendix C to this decision might relate to pending claims or pending litigation. Although the respondents did not offer much testimonial evidence with respect to their claim of exemption pursuant to §1-210(b)(4), G.S., it is clear from the face of the records that such records do not relate to *strategy* or *negotiations*, as those terms are defined in §§1-200(8) and 1-200(9), G.S.

36. It is therefore concluded that the in camera records, or portions thereof, identified in


Appendix C are not exempt from disclosure pursuant to §1-210(b)(4), G.S., as contended by the respondents.

37. Based on the foregoing, it is concluded that the respondents violated §§1-210(a) and 1-212(a), G.S., when they failed to disclose those records, or portions thereof, identified in Appendices B and C, attached hereto.

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

1. Within thirty days of the date of the Notice of Final Decision in this matter, the respondents shall disclose to the complainant, free of charge, the records, or portions thereof, described in paragraph 37 of the findings, above.
2. Henceforth, the respondents shall strictly comply with the disclosure requirements of §§1-210(a) and 1-212(a), G.S.


