The above-captioned matter was scheduled to be heard as a contested case on October 20, 2025, at which time the respondents appeared, but the complainant did not appear to prosecute the case.

Commission staff contacted the complainant by telephone to inquire about his absence, at which time he advised that he believed this matter had been resolved.

The undersigned hearing officer notes that Attorney Joseph M. Merly, counsel for the respondents, appeared at the hearing with one witness. Specifically, it is noted that Attorney Merly appeared with David Portela, a lieutenant with the respondent police department. Lieutenant Portela represented that he spent the better part of two days, or sixteen hours, "researching and procuring the materials" responsive to the request at issue. In addition, Lieutenant Portela represented that he provided approximately half of the records responsive to the request in respondents' possession to the complainant in September 2025, after receiving notice of the complaint from the Commission on September 24, 2025. The Lieutenant further represented that the only responsive records that had not been disclosed to the complainant, as of the date of the hearing, were body/surveillance footage, which were still in the queue for processing.

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

- 1. The complaint is hereby dismissed.
- 2. The complainant is admonished for his failure to appear at the hearing on this matter or to notify the Commission that the matter had been resolved, which failure resulted in a waste of scarce state resources.
