## **AMENDMENTS**

Docket #FIC 2017-0181

Kacey Lewis v. Commissioner, State of Connecticut, Department of Correction; and State of Connecticut, Department of Correction

The Hearing Officer's report is amended as follows:

- 2. By letter of complaint filed [December 24, 2015] **MARCH 27, 2017**, the complainant appealed to the Commission, alleging that the respondents violated the Freedom of Information ("FOI") Act by failing to comply with the Commission's order in Docket #FIC 2016-0279, <u>Lewis v. Department of Correction et al.</u> ("<u>Lewis I</u>"),
- 16. It is also concluded that the respondents' requirement **IN THIS CASE** that the complainant withdraw his complaint in order to receive the records on November 1, 2017 was [entirely] improper. The Commission's order in <u>Lewis I</u> was clearly unconditional. The respondents' impermissible demand for a withdrawal of the complaint resulted in an additional delay from November 1, 2017 to at least the date of the December hearing in this matter. (The email chain was offered into evidence, and subsequently was provided, at the complainant's request, to the complainant by the Commission, by depositing in the mail on December 14, 2017.)
