Colleen M. Murphy said that both would remain as temporary retired workers to help with transition. Chairman Eagan thanked both employees for their dedicated service to the Commission and the State of Connecticut.

AMENDMENTS

Docket #FIC 2021-0362

Jehroam Ormsby v. Jason Thody, Chief, Police Department, City of Hartford; Police Department, City of Hartford; and City of Hartford

The order in the Hearing Officer's Report is amended as follows:

- 1. Within fourteen (14) days of the date of the Notice of Final Decision in this matter, the respondents shall forthwith disclose to the complainant, free of charge, a copy of the records described in paragraph[s] 2(B) (LIMITED TO THE ARREST WARRANT APPLICATION, INCLUDING ANY AFFIDAVIT IN SUPPORT OF SUCH WARRANT), PROVIDED THAT THE ARREST WAS BY WARRANT; OR 2(F) (LIMITED TO THE OFFICIAL ARREST, INCIDENT OR SIMILAR REPORT), PROVIDED THAT THE ARREST WAS NOT BY WARRANT, IN SATISFACTION OF THE MANDATORY MINIMUM DISCLOSURE REQUIREMENTS SET FORTH IN SECTION 1-215, G.S.
- 2. Henceforth the respondents shall strictly comply with the disclosure provisions of §§1-210(a), [and] 1-212(a), AND 1-215, G.S.

Energy Policy Advocates v. Attorney General, State of Connecticut, Office of the Attorney General; and State of Connecticut, Office of the Attorney General

The Hearing Officer's Report is amended as follows:

- 11. After the hearing on this matter, the respondents were ordered to submit copies of all responsive records for which exemptions were being claimed, in whole or in part, for in camera inspection. The respondents complied with such order on March 17, 2021. The in camera records, consisting of 34 pages, were marked and will be referenced herein as [IC2020-0320-001 through IC2020-0320-034] IC 2020-0122-001 through IC 2020-0122-034.
- 12. With regard to the claim that all of the in camera records, [IC2020-0320-001 through IC2020-0320-0034] **IC 2020-0122-001 through IC 2020-0122-034**, are exempt from disclosure as strategy relating to pending litigation, §1-210(b)(4), G.S., provides that disclosure is not required of:

[r]ecords pertaining to strategy and negotiations with respect to pending claims or pending litigation to which the public agency is a party until such litigation or claim has been finally adjudicated or otherwise settled.

- 17. After careful in camera inspection of [IC2020-0320-001 through IC2020-00320-0034] <u>IC</u> <u>2020-0122-001 through IC 2020-0122-034</u>, it is clear from the face of those records that the redacted information is strategy with respect to pending litigation, as that term is defined in §1-200(9)(C), G.S. Moreover, it is found that, at the time of the hearing in this matter, the litigation had not been finally adjudicated or otherwise settled.
- 18. Accordingly, it is found that [IC2020-0320-001 through IC2020-0320-003] <u>IC 2020-0122-001 through IC 2020-0122-034</u> are exempt from disclosure pursuant to §1-210(b)(4), G.S. The Commission therefore need not analyze any of the other exemptions claimed by the respondents.
