AMENDMENTS

Russell Peeler v. Rebeca Garcia, Chief, Police Department, City of Bridgeport; Police Department, City of Bridgeort; and City of Bridgeport

The orders in the Hearing Officer's Report are amened as follows:

Paragraph 9 of the Hearing Officer's Report is amended as follows:

2. THE COMMISSION IS DEEPLY CONCERNED WITH THE RESPONDENTS' FAILURE TO REVIEW THE RECORDS AT ISSUE PRIOR TO THE CONTESTED CASE HEARING, FAILURE TO PRESENT EVIDENCE WITH RESPECT TO ANY CLAIMED EXEMPTIONS, AND FAILURE TO COMPLY WITH ITS ORDER IN PEELER 1. HOWEVER, DUE TO THE NATURE OF SOME OF THE INFORMATION THAT MAY BE CONTAINED IN THE RECORDS AT ISSUE, AND NOTWITHSTANDING PARAGRAPH 1 OF THE ORDER, ABOVE, THE COMMISSION DECLINES TO ORDER DISCLOSURE OF THE IDENTITY OF WITNESSES UNDER §1-210(b)(3)(A), G.S., AND SIGNED WITNESS STATEMENTS UNDER §1-210(b)(3)(C), G.S.

- **3.**[2.] The respondent Chief Rebeca Garcia shall remit to the Commission, within thirty days of the date of the Notice of Final Decision in this matter, a civil penalty in the amount of seven hundred and fifty dollars (\$750.00).
- **4.**[3.] Henceforth, the respondents shall strictly comply with the disclosure provisions in §§1-210(a) and 1-212(a), G.S.

Paragraph 12 of the Hearing Officer's Report is deleted and replaced with the following new paragraph 12:

12. IT IS FOUND THAT THE RESPONDENTS' ACTIONS AND COMMUNICATIONS WITH THE COMPLAINANT WERE REASONABLE UNDER THE CIRCUMSTANCES OF THIS CASE AND WERE NOT TANTAMOUNT TO A DENIAL WITHIN THE MEANING OF §1-206(b)(1), G.S.

Paragraph 13 of the Hearing Officer's Report is amended as follows:

13. Based on the foregoing **AND THE FACTS AND CIRCUMSTANCES OF THIS CASE**, it is concluded that the Commission lacks subject matter jurisdiction over the complaint.
