[Nevertheless, it is found that the complainant did not notify the Commission that she wished to withdraw her complaint with respect to the in camera records, described in paragraph 15, above, and the Commission has no evidence indicating that such records were actually received by the complainant.] HOWEVER, THE RESPONDENTS DID NOT REQUEST TO REOPEN THE HEARING TO SUBMIT ADDITIONAL EVIDENCE OR REQUEST TO FILE AN AFTER-FILED EXHIBIT ATTESTING THAT SUCH RECORDS WERE

PROVIDED TO THE COMPLAINANT. It is therefore concluded that the respondents violated §§1-210(a) and 1-212(a), G.S., by withholding such in camera records, or portions thereof, from the complainant.
