AMENDMENTS

Docket #FIC 2022-0550

Ian Cooke v. Commissioner, State of Connecticut, Department of Emergency Services and Public Protection; and State of Connecticut, Department of Emergency Services and Public Protection

Paragraph 42 of the Hearing Officer's Report is amended as follows:

42. It is further found, however, that the respondents exercised control over the personnel files at issue for purposes of responding to the complainant's request. It is found, **BASED ON THE TESTIMONY OF THE HR BUSINESS PARTNER**, that when DAS receives a request for records that are part of the personnel files of the respondents' employees, **IT IS THE GENERAL PRACTICE THAT** DAS notifies the respondents of such request and provides the respondents with the records that are responsive to the request. It is further found that the respondents review such records and decide what information, if any, to redact.

Docket #FIC 2022-0551 Robert Cushman v. Christopher Chute, Chief, Police Department, City of New Britain; Police Department, City of New Britain; and City of New Britain

Paragraph 45 of the Hearing Officer's Report is amended as follows:

45. It is found that the respondents are hampered by a heavy workload, that the complainant did not express a need to receive the requested records expeditiously, and that he had received, at least some of the records, from the Office of the State's Attorney. [Nevertheless,] **BASED UPON THE FACTS AND CIRCUMSTANCES OF THIS CASE**, it is found that a delay of almost nine months from the date the respondents' acknowledged receipt of the complainant's November 8th request to the date the final BWC videos were provided to the complainant was [not] prompt.

Paragraph 46 of the Hearing Officer's Report is amended as follows:

46. [Based on the facts and circumstances of this case, i] It is concluded **THEREFORE** that the respondents **DID NOT** violate[d] the promptness provisions of §§1-210(a) and 1-212(a), G.S., **UNDER THE FACTS AND CIRCUMSTANCES OF THIS CASE.**

Paragraph 3 of the order in the Hearing Officer's Report is amended as follows:

3. Henceforth, the respondents shall strictly comply with the [promptness and] disclosure requirements of §§1-210(a) and 1-212(a), G.S.
