At the end of the first sentence in Paragraph 14 of the Hearing Officer's Report add footnote 3:

THE COMMISSION CAUTIONS THE RESPONDENTS THAT THE TERM "VEXATIOUS" IS AN EXPRESS TERM THAT IS UTILIZED IN §1-206(B)(6), G.S., AND THAT SUCH TERM SHOULD NOT BE USED LIGHTLY; THE RESPONDENTS ARE DIRECTED TO THE STATUTORY PROVISIONS CONTAINED IN §1-206(B)(6), G.S., AND THE COMMISSION'S DECISIONS WITH RESPECT THERETO FOR THE INTERPRETATION OF VEXATIOUS REQUESTER UNDER THE FOI ACT.

At the end of Paragraph 14 of the Hearing Officer's Report add footnote 4:

ALTHOUGH THE RESPONDENTS ULTIMATELY DID NOT IMPOSE SUCH A CHARGE ON THE COMPLAINANT, THE COMMISSION CAUTIONS THE RESPONDENTS THAT THE IMPOSITION OF SUCH A CHARGE TO INSPECT OR REVIEW PUBLIC RECORDS IS NOT AUTHORIZED UNDER THE FOI ACT.
