Attorney Valicia D. Harmon reported that *Paul Michalski v. Freedom of Information Commission*, HHB-CV23-6077756-S, an appeal of the Commission's final decision in Docket No. FIC-2022-0120, *Paul Michalski v. Chairman, Board of Education, Town of Dairen, at al.*, had been remanded to the Commission for further proceedings.

Executive Director Colleen M. Murphy reported that Commissioner Sherman London, who served from 1996-2013, had passed away recently at the age of 102. Chairman Eagan asked to Commissioners and staff to participate in a moment of silence in remembrance of Commissioner London.

Executive Director Colleen M. Murphy reported that the Connecticut Foundation for Open Government was hosting a panel on the Freedom of Information Act on May 22, 2024, at 5:30 p.m. at the Bridgeport Public Library with Commission Attorney Mary-Kate Smith participating as a panelist.

The Commissioners unanimously voted to appoint Molly Steffes and Stephanie Tessmer as Acting Clerks of the Commission.

Docket #FIC 2023-0248 Heather Sutter and Bruce A. McDermott v. Town Manager, Town of Groton; and Town of Groton

Paragraphs 23k and 50 of the Hearing Officer's Report are amended as follows:

k. IC-2023-0248-006, Lines 178-180, **185** (not responsive; attorney-client privilege)

50. With respect to IC-2023-0248-003 (lines 79 and 90-98), IC-2023-0248-004 (lines 117 and 128-129), IC-2023-0248-005 (lines 148, 153-154, and 174-177), IC-2023-0248-006 (lines 178-**180** and 185), IC-2023-0248-006 (line 189 and line 190, up to and including the comma on line 190), IC-2023-0248-008 (lines 233-234 and 245-246), IC-2023-0248-009 (lines 266-272 and 277), and IC-2023-0248-009 (lines 280-282, up to and including the comma on line 282) it is found that: (i) the substance of such communications were actually disclosed by Attorney Cody at the June 15, 2022 PZC meeting; (ii) the Town and the PZC did not object to such disclosure; and (iii) Attorney Cody's comments were published in the publicly available meeting minutes of the PZC. It is therefore found that the attorney-client privilege has been waived for those portions of such records.
