The Hearing Officer's Report is amended as follows:

Strike Paragraphs 31 and 32.

Replace Paragraph 35(c) with the following:

ICR 2023-0391-008-021, ICR 2023-0391-022-034, and ICR 2023-0391-070-082 are earlier drafts of the document sent to the Adjutant General and disclosed to the complainant at Respondents' Exhibit 2, Bates #43-45. It is found, therefore, that these records constitute intra-agency reports within the meaning of §1-210(e)(1), G.S. It is found that comparing Respondents' Exhibit 2, Bates #43-45 to these earlier drafts shows significant revisions including, but not limited to, changes to the structure and phrasing of certain sections.
