AMENDMENTS*

Jason LaChapelle v. Bernie Dennler, First Selectman, Board of Selectmen, Town of Colchester; Board of Selectmen, Town of Colchester; and Town of Colchester

Paragraphs 54 and 64 and the order in the Hearing Officer's Report are amended as follows:

- 54. Here, the principle cited by the respondents, as described in paragraph 51, above, is not a basis for nondisclosure of the sample ballots and in-person ballots cast in the stand-alone budget referendum at issue in this matter. As explained in paragraph 52, above, any exemption from disclosure under the "otherwise provided" language of § 1-210 (a), G.S., must be based on express terms in federal law or **STATE** statute.
- 64. It is found that none of the circumstances described in paragraph 62, above, with respect to the budget referendum in this matter apply. It is therefore concluded that the absentee ballots are subject to the sealing, preservation and retention requirements described in paragraphs [56] **59** through [59] **62**, above.

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

- 1. [Forthwith]WITHIN 45 DAYS OF THE DATE OF THE NOTICE OF FINAL DECISION IN THIS MATTER, the respondents shall provide the complainant with copies of the requested sample and in-person ballots CAST IN THE JUNE 11, 2024 STAND-ALONE BUDGET REFRENDUM IN THIS MATTER, AND described in paragraphs 4 and 5 of the findings, above, free of charge.
- 2. Consistent with the Commission's final decision and orders in *Santanella*, the Commission declines to order the disclosure of the identity of individual voters, if written on any ballots cast in-person; therefore, in complying with paragraph 1 of this order, the respondents may redact such information, to the extent it exists, from the requested in-person ballots **REFERENCED IN PARAGRAPH 1 OF THE ORDER, ABOVE**.

- 3.]Henceforth, the respondents shall strictly comply with the disclosure requirements of §§1-210(a) and 1-212(a), G.S.
