The Hearing Officer's Report is amended as follows:

Paragraph 83:

83. The Commission has no desire to cast aside recommendations of the Secretary of the State. However, it must do so when it believes that such recommendations are contrary to law and the disclosure provisions of the FOI Act. The Commission finds that the recommendation described in paragraph 82, above, and the recommendations in the [updated] **UNDATED** and unsigned [opinion] letter, are erroneous, and stand in direct contradiction of § 1-210(a), G.S.

Order 1:

1. Within 45 days of the Notice of Final Decision **AFTER RECONSIDERATION** in this matter, the respondents shall provide the complainant with copies of the requested sample and inperson ballots cast at the June 11, 2024, stand-alone budget referendum in this matter, and described in paragraphs 4 and 5 of the findings, above, free of charge.

- [2.]3. Henceforth, the respondents shall strictly comply with the fee provisions of §§1-211 and 1-212, G.S.

The order in the Hearing Officer's Report is amended as follows:

- 1. Within thirty (30) days of the Notice of Final Decision in this matter, the respondents shall: (i) conduct a thorough and diligent search for all (both computer-stored and hardcopy) records described in paragraph 2 of the findings, above; and (ii) submit to the Commission an affidavit sworn to or attested by a person with the requisite knowledge describing details of such search which shall include, but not be limited to, the date the search was commenced, the locations searched, and the specific keywords used by the respondents to search computer-stored records. Such affidavit shall be submitted to the Commission via email, at <u>foi@ct.gov</u>, with copy to the complainant.
- 2. Within sixty (60) days of conducting such search, the respondents shall provide the complainant with all records responsive to his request described in paragraph 2 of the findings, above, unredacted and free of charge.
- 3. [In complying with paragraph 2 of the order above, the respondents may withhold or redact such records, or portions thereof, that are the subject of a mandatory exemption, including the attorney-client privilege, set forth in § 52-146r, G.S., as incorporated in §1-210(b)(10), G.S.]IN COMPLYING WITH PARAGRAPH 2 OF THE ORDER ABOVE, THE RESPONDENTS MAY WITHHOLD OR REDACT SUCH RECORDS, OR PORTIONS THEREOF, THAT ARE THE SUBJECT OF A MANDATORY EXEMPTION, INCLUDING THE ATTORNEY-CLIENT PRIVILEGE, SET FORTH IN § 52-146R, G.S., AS INCORPORATED IN §1-210(B)(10), G.S.
- 4. If any records are withheld pursuant to [a mandatory exemption as described in] paragraph 3 of this order, above, the respondents shall submit an affidavit sworn to or attested by a person with the requisite knowledge which identifies and briefly describes the withheld record and the statutory basis for withholding the record. Such affidavit shall be submitted within sixty (60) days of the Notice of Final Decision in this matter.
- 5. If the respondents fail to comply with any order set forth in paragraphs 1 through 4, above, the complainant may file an appeal with the Commission, and such appeal may be afforded expedited treatment. The respondents are cautioned that if, after a hearing, the Commission concludes that they have violated any order herein, the Commission will consider the imposition of a civil penalty for such violation(s).
- 6. Henceforth, the respondents shall strictly comply with the disclosure provisions of §\$1-210(a) and 1-212(a), G.S., and the fee provisions of §1-212(a), G.S.

2. IN THE EVENT THE COMPLAINANTS SUBMIT ANOTHER REQUEST TO THE RESPONDENTS FOR AUTOMATED LICENSE PLATE READER DATA FOR THE PAST 30 DAYS, AND SUCH REQUEST IS DENIED, THE COMPLAINANTS MAY APPEAL SUCH DENIAL TO THE COMMISSION, AND THE COMMISSION MAY AFFORD SUCH APPEAL EXPEDITED TREATMENT.
