## **Sustainability Performance Plan**

Executive Order 1 (EO 1) calls on Executive Branch agencies to advance environmental leadership and cost savings for taxpayers by reducing greenhouse gas emissions and other sustainability objectives in energy use in buildings and vehicles, water use, and waste disposal.

The goals of EO 1 include:

- 45% reduction in GHG emissions below 2001 levels.
- 10% reduction in water consumption from a FY20 baseline, and
- 25% reduction in waste disposal from a FY20 baseline.

Sustainability Performance Plans are plans drafted each year by Senior Sustainability Officers to detail agency progress and necessary goals, actions, and responsible parties to achieve the targets set in EO 1.

The CT Lottery moved from Rocky Hill to Wallingford in August of 2023. The new building specs included the following completed projects:

1. Lighting -

All LED lighting

All lights are individually programed, which includes the warehouse. Lights can be individual or grouped on motion sensors. Lights automatically turn off (after about 20 minutes) when the motion times out.

- 2. Doors Energy vestibules that protect against drafts.
- 3. Café New appliances, including mini refrigerators used in the office, are energy efficient.
- 4. Refrigerated water dispenser filling station(s) and water fountains (ADA) Floor standing model, no-touch, tracks number of bottles saved by refilling
- 5. Rest Rooms -

Toilets - high efficiency, ultra-low consumption, automatic flush
Sinks - high efficiency, sensor activated no-touch dispensing, single handle pull-down sensor
Soap dispensers - high efficiency, sensor activated no-touch dispensing
Paper towel dispensers - sensor activated no-touch dispensing, average 8" length

Projected savings are unknown, as this is a new (to us) building, we don't have the benchmark ability to compare to previous expenses.

#### **Future Plans**

5. What planned sustainability initiatives beyond FY23 does your agency have relating to GHG reduction, water use reduction, and waste reduction?

We will continue to recycle used pallets. We will continue to clean and reuse acrylic dispensers. We will continue to utilize the state surplus for various materials, which saves our landfill footprint.
