# **Sustainability Performance Plan**

Executive Order 1 (EO 1) calls on Executive Branch agencies to advance environmental leadership and cost savings for taxpayers by reducing greenhouse gas emissions and other sustainability objectives in energy use in buildings and vehicles, water use, and waste disposal.

The goals of EO 1 include:

- 45% reduction in GHG emissions below 2001 levels.
- 10% reduction in water consumption from a FY20 baseline, and
- 25% reduction in waste disposal from a FY20 baseline.

Sustainability Performance Plans are plans drafted each year by Senior Sustainability Officers to detail agency progress and necessary goals, actions, and responsible parties to achieve the targets set in EO 1.

# **GreenerGov CT Participation Overview**

#### 1. How has your agency worked towards the sustainability goals of EO 1 in FY23?

Our agency has attempted to install Solar panels on one of the homes (50 Taos Drive, Danielson, CT) to reduce our energy costs at DDS. This initiative was part of a Pilot program through an MOA with DEEP. Through this MOA, DDS has also upgraded HVAC and Windows to increase energy efficiencies.

DDS has monitored teleworking employees to track GHG reduction by DDS employees. 956 teleworking DDS employees made over 179,942 less trips than pre EO 1 levels.

DDS has also update AC units and window to promote efficiency across various locations
