The communication below was sent out to all Connecticut Vaccine Program (CVP) enrolled providers Tuesday, October 11. The current re-enrollment is for CT's pediatric program (referred to as the CVP) administered by the CT Department of Public Health. **Both the federal COVID-19 vaccine program and state COVID-19 Vaccine Program (CoVP), are separate programs and re-enrollment is not needed at this time.**

**SUBJECT:** Re-enrollment in the Connecticut Vaccine Program

The primary purpose of this communication is to notify all providers of the need to complete a provider profile and provider agreement form for re-enrollment in the Connecticut Vaccine Program (CVP) for calendar year 2023.

### Re-enrollment Process

In order to participate in the CVP **each provider site** is federally mandated to complete and submit a provider profile and provider agreement on a yearly basis. The re-enrollment process allows us to verify and update provider shipping information as well as to estimate the amount of vaccine that will need to be supplied for the upcoming calendar year.

**Again this year the re-enrollment process for the CVP will be all electronic in CT's Immunization Information System, CT WiZ.** The Primary CVP Coordinator and the physician signing the agreement (or equivalent) will each need to have an individual CT WiZ username and password to complete the provider profile and provider agreement. **The completed provider profile and provider agreement forms must be submitted in CT WiZ to the Connecticut Vaccine Program by December 12, 2022.** Meeting this deadline will allow all providers to continue receiving state supplied vaccine on an uninterrupted basis. Failure to complete the profile and agreement forms by December 12<sup>th</sup> will result in a delay of your January vaccine order. If your clinic no longer wishes to participate in the program, please submit a [help desk ticket](#) and select Immunizations (CT WiZ)-Clinic Administration-Report Clinic Closure.
