**SUBJECT:** Update on Seasonal Flu Vaccine -Flucelvax® now available

The purpose of this communication is to notify you of the availability of Flucelvax® vaccine.

#### **Pediatric Influenza Vaccine**

The Advisory Committee on Immunization Practices (ACIP) recommends that all children aged 6 months through 18 years be vaccinated yearly against influenza. For the 2022–23 flu season the CVP will only be supplying Quadrivalent vaccines licensed for use. The full 2022 Influenza Vaccine Recommendations will soon be available at: [www.cdc.gov/mmwr](http://www.cdc.gov/mmwr).

The Immunization Program will provide several different formulations of vaccine available to immunize **all children aged 6 months through 18 years of age regardless of insurance status.**

**Flucelvax®**, **Fluzone®** and **FluLaval®** are now available for order thru the CVP. Please limit your vaccine request to your actual need for the current month. The majority of our influenza vaccine supply is expected to be available by September and October. To avoid vaccine wastage be sure to order only what you need for the current month and not for the entire flu season. Since providers can order as often as they like the CVP encourages providers to order smaller quantities of flu vaccine several times during the course of a month keeping in mind how much storage capacity you have in your refrigerator to safely keep all childhood vaccines at the proper temperatures.
