Dear CVFA providers,

All providers must complete a re-enrollment for the calendar year 2025 electronically in CT WiZ.

Re-enrollment Process

To participate in the CVFA, **each provider site** is required by CDC to submit a provider profile and agreement annually to re-enroll. The re-enrollment process allows us to verify and update provider shipping information as well as to estimate the amount of vaccine that will need to be supplied for the upcoming calendar year.

Please complete your re-enrollment electronically in CT's Immunization Information System, CT WiZ; paper forms will not be accepted. The Primary CVFA Coordinator and the Medical Director (or equivalent) signing the agreement will each need to have an individual CT WiZ username and password. Visit our re-enrollment page at CT Vaccine Providers on the Department of Public Health website for instructions on how to complete the process. Be sure to review the Re-Enrollment Checklist and complete the prerequisite steps before getting started. If you need your CT WiZ password reset, click here.
