Dear CVP providers,

All providers must complete a re-enrollment for the calendar year 2025 electronically in CT WiZ.

Re-enrollment Process

To participate in the CVP, **each provider site** is required by CDC to submit a provider profile and agreement annually to re-enroll. The re-enrollment process allows us to verify and update provider shipping information as well as to estimate the amount of vaccine that will need to be supplied for the upcoming calendar year.

**Please complete your re-enrollment electronically in CT's Immunization Information System, CT WiZ;** paper forms will not be accepted. The Primary CVP Coordinator and the Medical Director (or equivalent) signing the agreement will each need to have an individual CT WiZ username and password. - **Providers must complete re-enrollment in CT WiZ by November 15, 2024.**

Meeting this deadline will allow you to continue receiving state supplied vaccine without any interruptions. Failure to complete the profile and agreement forms by November 15<sup>th</sup> will result in a delay of future vaccine orders.
