Dear CVP providers,

The Advisory Committee on Immunization Practices (ACIP) recommends that all children aged 6 months through 18 years be vaccinated annually against influenza. The full 2024–2025 influenza vaccine recommendations will soon be available at: <u>www.cdc.gov/mmwr</u>.

The Immunization Program will make several different **trivalent** formulations available to vaccinate **all children aged 6 months through 18 years of age regardless of insurance status.** <u>Use of Trivalent Influenza</u> <u>Vaccines for the 2024-2025 U.S. Influenza Season | FDA</u>

FluLaval[®] *is now available for order through the CVP*. We will notify you when additional formulations become available.

Remember that you can order as often as needed during the course of the month so the CVP encourages providers to order smaller quantities of flu vaccine allowing for the safe storage of all your childhood vaccines at the proper temperature. The majority of our influenza vaccine supply is expected to be available by September and October.
