AN ACT CONCERNING ESSENTIAL SUPPORT PERSONS AND A STATE-WIDE VISITATION POLICY FOR RESIDENTS OF LONGTERM CARE FACILITIES.

Public Act No. 21-71 | Previously H.B. 6634

- Effective Date: Effective from passage
- This bill allows long-term care facility residents, or their representatives, to designate an essential support person and a secondary essential support person who may visit the resident despite general visitation restrictions imposed on other visitors subject to DPH guidance.
- The bill applies to residents in nursing homes and managed residential communities that provide assisted living services. Ombudsman statutes expanded to specifically include resident support for socialization, visitation, and essential support person access.`

AN ACT CONCERNING NURSING HOMES AND DEMENTIA SPECIAL CARE UNITS. Public Act No. 21-185 | Previously S.B. 1030

Effective dates vary but most October 1, 2021

Required to employ a full-time infection and prevention control specialist

Requires nursing homes to maintain at least a two-month supply of personal protective equipment for their staff;

Requires a nursing home's administrative head to ensure there is at least one staff member or contracted professional available on-call during each shift who is licensed or certified to start an intravenous line;

Requires Nursing Homes to provide at least 3 hours of direct care per resident per day (the current requirement is 1.9 hours per resident per day).

Requires each nursing home's and dementia special care unit's administrative head, by January 1, 2022, to encourage and assist in the establishment of a family council to encourage and support open communication between the facility and residents' families and friends

Effective Date: October 1, 2021

- The bill specifies access rights and limitations to resident audio or video virtual recordings and outlines ombudsman right to ask residents/responsible parties about recordings that may corroborate abuse or neglect allegations.
- Residents Pay For the Technology and It's Installation, and the nursing homes are responsible for the internet access and power to run the devices.

Appropriations Budget Bill

House Bill No. 6689 | Special Act No. 21-15

Effective Date: July 1st 2021

• Increase of the Personal Needs Allowance for LTC Residents on Medicaid from \$60/month to \$75/month.

AN ACT STRENGTHENING THE VOICE OF RESIDENTS AND FAMILY COUNCILS.

Public Act No. 21-194 | Previously S.B. 973

- Effective From Passage
- Applies to Nursing Facilities and Managed Residential Care Facilities / Assisted Living Facilities
- This legislation will require input from resident and family councils at long-term care facilities on any statewide policies affecting living conditions for residents of such facilities.
- Agency or Legislative Committees will be required to hold a public hearing upon the request of fifteen or more persons not later than fourteen days after the date such notice of intent is posted on the eRegulations System.
- Testimony shall be accepted in a manner and format that provides for the greatest input from members of resident's councils and family councils including remote testimony.

Federal Advocacy and H.R. 3733

- H.R. 3733: The Essential Caregivers Act, led by U.S. Representatives Claudia Tenney and John B. Larson
- Allows essential caregivers access to long-term facilities to provide care and support to a facility resident during any public health emergency.
