MINUTES OF THE MANAGEMENT ADVISORY COUNCIL June 18, 2014

Ram Aberasturia, MAC Chair, called the meeting to order at 9:00 a.m. and thanked those in attendance for their participation.

Guest Presentation

The guest speaker for the June 18 meeting was Brenda Halpin, Director of the Retirement Services Division in the Office of the State Comptroller. Ms. Halpin's presentation was: "What Folks Need to Know When Getting Ready to Retire". Brenda was accompanied by: Bonnie Price, Assistant Division Director overseeing the retirement payroll section as well as small retirement systems such as the Alternate Retirement Plan; Donald Wilkerson, Assistant Division Director overseeing the purchase of service credit and audit units; and Kishore Solanki, Assistant Division Director overseeing the retirement counseling section.

Ram welcomed and thanked the panelists. He also acknowledged Debi Freund for arranging for today's presentation.

Brenda thanked MAC for hosting the presentation. She noted that it will not be possible today to have a full discussion of retirement health benefits. Dr. Thomas Woodruff will be available for a future date to present on that topic, and Debi Freund will coordinate with the Comptroller's Office to make the necessary arrangement for that follow-up presentation.

Brenda indicated that the retirement system must handle a tremendous amount of data. A current initiative is to upgrade the system. The upgraded system will provide self-service for retirees to update information such as direct deposit and address changes. The upgraded system is also being designed to integrate retirement payroll with health care benefits.

Brenda presented the Comptroller's retirement workshop for Tier II/IIA employees. If employees plan to attend a Tier II/IIA workshop, they should plan ahead and come to the workshop with a calculation of benefits in hand. The workshop is available on the Comptroller's website at:

 Department of Energy and Environmental Protection (no update available); Commission on Human Rights and Opportunities (election in process); Department of Social Services (election in process).

Old Business

<u>Speakers and Logistics.</u> Debi confirmed that she will be reaching out to Dr. Thomas Woodruff for an upcoming presentation focusing on retirement health benefits.

Web Content/Communications/Orientation Committee. Elise reported that Nancy Nicolescu provided an email as she was not able to be at today's meeting. Elise reported on behalf of Nancy that she has been performing routine updates to the website such as meeting notices and minutes.
