Report from Managers Day 2016 Planning Committee. The planning committee met after the October 21 business meeting. A site visit was conducted to Central Connecticut State University (CCSU), and it was determined that it would not be a more cost-effective venue than the AquaTurf. Additionally, the CCSU campus would be more difficult to navigate and there were space constraints, making the site less desirable. The committee is still looking for speakers recommendations for the event. The AquaTurf has been reserved for September 30, 2016. Ram is still attempting to schedule a meeting with the Office of Policy and Management; a request is pending. We are attempting to confirm the availability of funding, since it will not be possible to hold the event without a commitment of funding.
