Welcome and Introductions

Ram Aberasturia, MAC Chair, called the meeting to order at 9:04 a.m. Ram welcomed and introduced the Commissioner of Veterans' Affairs, Sean Connolly, our guest speaker, and thanked him for taking time from his busy schedule to speak with state managers.

Guest Speaker

Commissioner Connolly made a very informative PowerPoint presentation, in which he described the mission, vision, programs and services of the Department of Veterans' Affairs. At the conclusion of the presentation, a very enthusiastic discussion took place regarding the potential for broadening interagency collaborations. The PowerPoint presentation will be made available for posting on the MAC website. Commissioner Connolly asked if any veterans were present, and Chris Beloff and Donna Brillant identified that they were both veterans of service in the Army. Commissioner Connolly presented them with medals commemorating their service.

Approval of Minutes

The draft minutes of the September 21, 2016 MAC meeting were distributed to the membership via the list serv. The minutes were approved unanimously, as submitted.

Treasurer's Report

Maura Welch, MAC Treasurer, reported that the balance in the treasury is \$2,387.90 as of September 30, 2016. For the month of September 2016, expenses included the purchase of the Distinguished Managerial Service Awards and the payment to Aqua Turf for meals and audio/visual equipment rental. Registration fees were deposited and a dividend was credited. The closeout of Managers Day 2016 is still in progress, with payments to be made for speakers' donations and travel expenses, as well as the submission for reimbursement to the Office of Policy and Management. The Treasurer's report was distributed to the membership via the list serv and was approved unanimously, as submitted.

Credentials Report

Deb Paradis, MAC Credentials Chair, reported that Lateisha Rainey has transferred, leaving a vacancy for the Alternate in the Department of Developmental Services. DDS is in process of filling this slot. There is a need to finalize the letter to go out to agency heads regarding elections for terms beginning January 1, 2017.

Peggy offered to follow up and bring back whatever information she could identify for today's meeting. Peggy indicated that she has reached out to UConn and is awaiting their response.

<u>Feedback from Managers Day 2016 Survey.</u> Peggy Zabawar reported on the results of the survey sent to attendees at Managers Day 2016. There was an exceptionally high response rate, and overall the feedback was very favorable. Respondents were very pleased with the caliber of the speakers and the program. There were a number of new attendees this year, many of whom responded to the survey.

<u>Volunteers for Managers Day 2017 Planning Committee.</u> There will be a meeting of the planning committee following the adjournment of the regular business meeting. Ram invited anyone interested in serving to attend.

Other New Business. It was pointed out that the Association of Managerial Employees in Connecticut State Service is very active on a number of issues at this time. AMECSS is interested in having more regular communication with MAC. This was taken under advisement and will be discussed further by the Executive Board. It is important to note that MAC serves the Administration and has a very different charge as spelled out in the Governor's Executive Order that established the organization.
