# MINUTES OF THE MANAGEMENT ADVISORY COUNCIL August 15, 2018

#### Welcome and Introductions

The regular monthly meeting of the Management Advisory Council was held on Wednesday, August 15<sup>th</sup>, 2018 at the Department of Transportation in Newington, Connecticut. Chair Janice Deshais called the meeting to order at 9:07 AM.

#### **Approval of Minutes**

The minutes of the June 20<sup>th</sup> and July 18<sup>th</sup> meeting were approved with Nancy Nicolescu abstaining from the vote on the June 20<sup>th</sup> minutes.

#### Treasurer's Report

Meredith Minnocci, MAC Treasurer, reported that the balance in the treasury was \$2706.80 as of July 31, 2018, reflecting a \$18.00 expenditure for new checks since the last report. The Treasurer's report was circulated via the list serv. The report was approved unanimously, as submitted.

#### **Credentials Report**

Deb Paradis, MAC Credentials Chair, reported that the only outstanding agency elections are CHRO and the Office of the Treasurer. The Credentials list is posted on the website. Nancy Nicolescu volunteered to reach out to CHRO and the Office of the Treasurer.

#### **Old Business**

<u>Speakers and Logistics for Upcoming Meetings.</u> Chair Deshais reflected upon the success of Mr. John Herrington's presentation at July 18, 2018 meeting at Gateway Community College and suggested that the Council host a second retirement presentation more accessible to managers working out of offices in the southern part of the state. Several locations were suggested and committee members were encouraged to follow up with Chair Deshais with possible locations. Nancy Nicolescu expressed an interest in having the Council host an event for managers in November or December.

<u>Web Content/Communications/Orientation Committee.</u> Nancy Nicolescu indicated that the Council's website is up to date and that she will continue to perform regular updates. Ms. Nicolescu announced that the registration portal for Managers Day is accessible along with the donation page for this year's charity: Foodshare.

<u>Status of Updates to MAC list-serv.</u> Ms. Nicolescu reported that the list-serve currently contains 1036 managers and reported that some Fiscal and Administrative Managers have been removed due to unionization. Wanda Seldon suggested that Human Resource professionals play a role in adding managers to the Council's list-serve.

Jeri Beckford nominated herself for the position. There were no further nominations and nominations were closed. Chair Deshais declared Ms. Beckford elected by acclamation. There were no objections. The executive board welcomed the new Secretary.
