**Park in Pitkin Street Lot.** Enter lot at gate From the lot, head to the right on East River Drive. Riverview Square is on the left, 101 East River Drive is the first building. On arrival, sign in at the security station. Conference Room 1002 A/B is to the left of the security station.

From I-91 Southbound

In downtown Hartford, take a left exit onto I-84 East  
Take Exit 53, East River Drive/Connecticut Blvd  
Bear right to stop sign, turn right onto East River Drive  
Pass Riverview Square on the right (101 is the first building)  
Turn left at next stop sign onto Pitkin Street, the lot is on the left

From I-91 Northbound

Take Exit 29 (Rtes. 5/15 and I-84 East)  
Stay in right lane, take first exit, bearing right for Route 2 West  
Don't merge with Route 2 traffic  
Stay in the exit lane, which becomes Exit 4, to East River Drive  
At the traffic light at the end of ramp, turn left onto East River Drive  
Go straight through the next traffic light  
At second stop sign, turn right onto Pitkin Street, the lot is on the left

From I-84 Eastbound

Take Exit 53, East River Drive  
Bear right to stop sign, turn right onto East River Drive  
Pass Riverview Square on the right  
Turn left at next stop sign onto Pitkin Street, the lot is on the left

From I-84 Westbound

Take Exit 54 (Downtown Hartford)  
Take first exit for Darlin Street  
At end of ramp, turn left  
At the stop sign, turn left onto East River Drive  
Pass Riverview Square on the right (approximately 1/4 mile)  
Turn left at next stop sign onto Pitkin Street, the lot is on the left

From Route 2 Westbound

Take Exit 4 to East River Drive  
At the traffic light at the end of ramp turn left onto East River Drive  
At the next traffic light go straight,  
At second stop sign, turn right onto Pitkin Street, the lot is on the left
