CONNECTICUT MILITARY DEPARTMENT RECOMMENDATION FOR STATE AWARD



PURPOSE: To recommend members of the Armed Forces of the State of Connecticut and the

AUTHORITY: Connecticut General Statutes Sections 27-72, 27-73, 27-73a through 27-73h;

INSTRUCTIONS: Any member of the Armed Forces of the State of Connecticut may recommend another individual of the Armed Forces of the State for a state award as stated in the Connecticut General Statutes.

- Nominee Information: Provided the requested information on the individual being recommended for an award. Awards for achievement are generally for a singular event or series of events over a short period of time. Service awards are cumulative awards over a longer period of time, usually submitted at the conclusion of an assignment or career.
- Recommender Information: Provide the requested information about yourself. You must sign the award before submitting.
- Justification: It is only mandatory to complete one achievement. However, that achievement
 must justify the purpose of the award. Singular achievements may not justify an award, but
 cumulatively they warrant the proposed award.
- Recommendations/Approvals/Disapprovals.
 - The first intermediate authority is the nominee's immediate Commander or Commandant. (Not the recommender)
 - Subsequent intermediate authorities are the chain of command up to the Approval Authority.
 - The Approval Authority is The Adjutant General of the State of Connecticut for all state awards
 - Guidance on recommendations: Regardless of the Intermediate Authority's
 recommendation, the award must complete the process up the chain of command to
 the Approval Authority. Only the Approval Authority has to approve, disapprove,
 upgrade or downgrade the recommend award. An Intermediate Authority may request
 the recommender to rewrite the recommendation if they believe the achievements do
 not warrant the recommended award, but may not deny the award.
