Substance Exposure

OCA testified in support of H.B No 5155, which is an act concerning the safe storage of cannabis, cannabis products and prescription drugs. The bill is gaining support from various CFRP stakeholders. A few panel members attended the CT Alcohol and Drug Policy Council (ADPC) this week. There are discussions and information sharing happening at the subcommittee level with regards to safe storage. Children were impacted by legalization and there is misinformation about that impact, therefore CFRP will release a white paper with facts about ingestion and resources for parents. In response to substance exposed infants, DHMAS will work with Beacon to create an access line for mothers with a perinatal counselor, extending Access mental health for kids to mothers.
