Minutes

CFRP Data/Discussion

There have been 9 cases reported to the OCA for the month of June so far, there are several cases pending further study, one accident and one suicide. The accident was an MVA, that was heavily covered by local media. The pending cases include a possible drowning

and 4 cases in which co-sleeping/ unsafe sleep situation was a possible factor. A breakdown of 2023 cases shows that there were 66 cases for the year, which was less than the 87 cases for 2022. We have 38 cases for the first 6-months of 2024 with 12 cases pending further study. The numbers of Undetermined cases which involve unsafe factors has remained stable for the past decade or so. Safe sleep messaging was discussed. An Accidental Ingestion Workgroup has been established in CT; this collaboration was created based on the Marcello M. fatality report. The AIW group will meet for the first time this afternoon.

Drowning Data/ Discussion

There were 41 drownings in CT from 2014-2023, Manners for most of those drownings were Accidental with a few Homicides. About 9 % of children who drown in CT are not residents but visiting. Demographics of drowning victims were discussed, 30 % white, 30% Hispanic and 40 %Black, black children tend to be older than the other demographics at the time of the drowning. Of CT's children, males drown more often than females which is consistent with the national data. 21 of the drownings occurred in open bodies of water., 14 occurred in pools, 4 in bathtubs and 2 in buckets. Education for older kids about water safety and supervision of younger children were discussed. Mitigation of risks factors were discussed such as water watchers and increasing barriers to accessing bodies of water. Evidence based drowning prevention plans include barriers, data collection to identify groups at risk, increasing access to life jackets, CPR lessons, swimming lessons and supervision.

Adolescent deaths-

Officials have noticed an increase in cannabis impaired driving, field sobriety tests for marijuana have not been developed yet. There are a few special PD units that are trained in detection of cannabis impairment however they are only a few of them in CT. Graduated license program was discussed and its correlation to adolescent MVAs, there is currently no mechanism in place to collect data about accidents involving those who are in the graduated license program vs licenses after age 18. OCA met with stake holders to discuss adolescent SA treatment services, the goal was to integrate SA screening and early intervention into behavioral health screenings and treatment. Panel members discussed giving youths the opportunity to discuss their needs in an open and honest forum. There are gaps in services provided and screening, perhaps using the youth services bureau and juvenile court services to hear more about the kids' experiences. Engagement, case management and a stable living environment could be vital to children in recovery. Interventions at an earlier age and in real time for older kids who need help now are essential.
