MM 2nd – Unanimous to approve the minutes of the September 12, 2023, Commission Meeting

Presentation by the CPD on the following:

Requesting that the three organizations proposed to provide training and education services to the agency be scheduled to present at the November Commission meeting:

- 1. Thought Partner Solutions
- 2. Dr. Isabel Logan
- 3. YWCA Greenwich

CPD provided three quotes for agency products intended to enhance recruitment.

Q&A by commission members followed.

MM 2nd – Unanimous to discuss achieving salary parity with the State's Attorneys.

Presentation by Laila Haswell, President Local 381, and Anthony Bento, Representative Attorney's 381, regarding the proposed salary restructuring of the union attorney's pay scale to 15 increment steps from the current increment steps to ensure pay equity with the State's Attorneys' union pay scale.

Discussion among the commission members, the CPD and attorneys Haswell and Bento followed regarding the importance of the implementation of this restructuring as soon as possible in order to put the Division attorneys on the same scale at the State's Attorneys to ensure a level and equal bargaining position for wage reopening discussions in January 2024.

• Justice Palmer highlighted a discussion that occurred between Paula Lohr and Karen Buffkin regarding wage equality and negotiations — though this person is not currently employed by OPM. Justice Palmer went on to report that he and the commission members believe there is no legal barrier to the implementation of these pay scale adjustments, and it should be done now.

Further Q&A followed with Stephen Hunt, Financial Director, regarding the budgetary implications for instituting these pay scale adjustments and the mechanics for doing so. Mr. Hunt reported the following:

- The funds are currently within the fiscal year appropriation to cover the cost.
- It would be accomplished through the transferring of funds between accounts.
- He has already alerted OPM of this budget adjustment, and they are aware.

Additional Q&A between the commission members and the CPD followed.

- Attorney Jefferson requested that the CPD "take the steps to get this restructure accomplished immediately."
- Justice Palmer commented that the delay in the implementation has been unnecessary.
- Attorney Jefferson requested that Attorney Haswell and the CPD both commit to "get this done in 48 hours" to which both agreed.
- Judge Solomon indicated the need for OCPD to "regain and retain statutory parity with the State's Attorneys."

Presentation by Deborah Del Prete Sullivan on the following:

- Ongoing efforts regarding the "trial tax" penalty survey project and MOU
- The Risk Protection Orders and new policy
- Request approval to pay a \$5180.00 fee for the cost of a MOU (MM 2nd approved)

A Period of Public Commentary Followed:

- Kymberly Cianci, Administrative Services Officer, announced she had accepted a position at another state agency and read aloud a letter of support for the CPD.
- David Warner, Supervisory Assistant Public Defender, GA#14, commented on the delays in filling positions within his office and frustrations these delays cause due to the caseload burdens that result for the remaining staff.

Q&A by commission members followed.

Attorney Jefferson inquired directly of Paula Lohr regarding the GA#14 hiring delays and was assured that a notice for a new attorney position would be posted tomorrow.

- Attorney Laura Bryll of the Hartford JD commented on the process for receiving approval for hiring experts in cases and the rates paid.
- Attorney Diana Gomez, GA #5, commented on the demands that the Risk Protection Orders are causing and how they are impacting the time available to handle the daily business in her court location – and that her office is currently down one attorney.

The reprimand clearly outlines steps the commission expects the CPD to take to correct the behavior contained in the letter. In addition, the chair indicated that further review will be done on an ongoing basis.

Judge Solomon made clear that the commission "takes no pleasure" in issuing the aforementioned reprimand and that the members believe that this letter is the "least form of sanction" the commission could take at this time.
