Attorney Bowden-Lewis then left the meeting having been provided with a letter regarding the leave.

Justice Palmer indicated that regarding Greg Dion being placed on Administrative Leave, there was no basis for such, it was unjustified and inappropriate, and that the action was reversed and retracted. Paula Lohr would be advised accordingly.

MM  $2^{nd}$  Unanimous in support of the above action.

Justice Palmer indicated that in regard to the Letter of Reprimand issued to Deborah Del Prete Sullivan, there was no basis for such, the action was unjustified and inappropriate, and that the action was reversed and retracted. Paula Lohr would be advised accordingly.

MM 2<sup>nd</sup> Unanimous in support of the above action.

Justice Palmer read from a document and directed that the document be made a part of the recorded minutes (attached).

Justice Palmer indicated that the Deputy Chief Public Defender, John Day, will now be the Acting Chief Public Defender and discharge the duties accordingly.

MM 2<sup>nd</sup> Unanimous to appoint John Day as the Acting Chief Public Defender.

Judge Shiela Prats commented that she has known Attorney Bowden-Lewis since she was in Waterbury and that it was with a heavy heart that she voted today to place her on Administrative Leave, but that it was the right decision to make.

To be reflected in the Commission's minutes for February 9, 2024:

## Deborah Del Prete Sullivan

Having reviewed the matter of the Letter of Reprimand issued to Deborah Del Prete Sullivan on February 8, 2024, the Commission finds and concludes that there was no basis in fact or law for that action and, therefore, the issuance of that Letter of Reprimand was unjustified and inappropriate.

Accordingly, the Letter of Reprimand is hereby retracted, and any document, including any document electronically recorded, reflecting the issuance of the Letter of Reprimand shall be expunged from and physically removed from Attorney Sullivan's personnel file and any other file, including any electronic file, maintained by the Division of Public Defender Services.

In addition, any and all persons employed by the Division of Public Defender Services, including but not limited to any and all persons responsible for or involved in the issuance of the Letter of Reprimand, are hereby directed to remove any document reflecting the issuance of the Letter of Reprimand from any file, including electronic files, within their possession and return all copies and records pertaining to the Letter of Reprimand to the Public Defender Services Commission.
