#### LAW STUDENT AND UNDERGRAD LEGAL INTERNSHIPS

The following is a list of Division Public Defender field offices and the name and email address of the supervisory head of each office. Please send an intern application (below), cover letter, and a current resume to the office head of the Public Defender office in which you would like to intern and obtain an interview. Simultaneous submissions to different offices are acceptable.

#### General Information:

- Certified Legal Intern Law students who are eligible for certification under Practice Book Section 3-14 et. seq., may appear in court. Read the requirements in the Practice Book and/or check with your school Dean.
- A background check is required and will be conducted for students who will be interning with our division.
- A mandatory intern orientation will be held either in-person or virtually at the beginning of each term.
- All internships are unpaid.
- As placements are not guaranteed, we encourage students to also seek other internship opportunities.
- Applications will be accepted on a rolling basis, so feel free to submit paperwork to a field office
  at any time but please make sure you indicate for which semester you are applying.
- GENERAL GUIDELINES FOR SUBMISSIONS:
  - SUMMER internships submit paperwork beginning in January.
  - o FALL internships submit paperwork beginning in April.
  - SPRING internships submit paperwork beginning in August.
