INTERNSHIPS for students interested in LAW, INVESTIGATION & SOCIAL WORK

INTERNSHIP TERMS and GENERAL GUIDELINES:

- SUMMER internships – Usually May, June, July, August
(TYPICALLY APPLY BEGINNING IN JANUARY)
- FALL internships – Usually August, September, October, November, December
(TYPICALLY APPLY BEGINNING IN MAY)
- WINTER/SPRING internships– Usually January, February, March, April, May
(TYPICALLY APPLY BEGINNING IN AUGUST)

General Information Applicable to All:

- All internships are unpaid.
- A background check is required and will be conducted for all students interning with us.
- A 3 hour mandatory intern orientation will be held virtually at the beginning of each term.
- Since applications are rolling, they can be submitted at any time for any term.
- Please be sure to indicate for which of our 3 Internship Terms you are applying.
- Please review the list of our locations (attached) for those within a commutable distance.
- Please complete the intern application (attached), prepare a cover letter, and current resume.
- Placement is not assured until the internship offer is extended following submission of the application/resume/cover letter, and successful completion of the interview process, background check, and non-disclosure agreement.

FOR LAW STUDENT and UNDERGRAD LEGAL INTERNSHIPS:

- Email the application/resume/cover letter to the supervisor or designee at any Public Defender location at which you are willing to intern, for their consideration.
- Due to limited availability, simultaneous submissions to multiple offices are recommended.
- Law Students who are eligible for certification under the Connecticut Practice Book Sections 3-14 to 21 may appear in court as Certified Legal Interns during their internships with us. Read the requirements in the Practice Book (available online) and work with your law school Dean to document eligibility.

FOR SOCIAL WORK or INVESTIGATION INTERNSHIPS:
