**BILL NOTIFICATION 2021-25** 

July 12, 2021

Governor Lamont signed the following legislation of the 2021 Regular Session on July 12:

AN ACT REQUIRING THE REPORTING OF ACCIDENTS THAT RESULTED
IN SERIOUS PHYSICAL INJURIES OR DEATH AT INSTITUTIONS OF
HIGHER EDUCATION.
AN ACT RESTRUCTURING UNEMPLOYMENT INSURANCE BENEFITS
AND IMPROVING FUND SOLVENCY.

As of this date, the governor has signed two hundred eight (208) bills and vetoed one (1) bill of the 2021 Regular Session. He has also signed two (2) bills of the June 2021 Special Session.
