



**BILL NOTIFICATION 2024-5** 

May 22, 2024

Governor Lamont signed the following legislation of the 2024 Regular Session on May 21:

SB 1 PA 24-19	AN ACT CONCERNING THE HEALTH AND SAFETY OF CONNECTICUT RESIDENTS.
SB 183 PA 24-20	AN ACT IMPLEMENTING THE RECOMMENDATIONS OF THE DEPARTMENT OF MOTOR VEHICLES AND CONCERNING LOW-SPEED VEHICLES, THE TOWING OF OCCUPIED VEHICLES, SCHOOL BUSES, ELECTRIC COMMERCIAL VEHICLES, THE PASSENGER REGISTRATION OF PICK-UP TRUCKS AND REMOVABLE WINDSHIELD PLACARDS FOR PERSONS WHO ARE BLIND AND PERSONS WITH DISABILITIES.

HB 5487 PA 24-44	AN ACT CONCERNING THE OPERATION AND ADMINISTRATION OF THE OFFICE OF THE CLAIMS COMMISSIONER.
HB 5437 PA 24-45	AN ACT CONCERNING EDUCATION MANDATE RELIEF, SCHOOL DISCIPLINE AND DISCONNECTED YOUTH.
HB 5491 PA 24-46	AN ACT ESTABLISHING A PROPERTY TAX EXEMPTION FOR VETERANS WHO HAVE A SERVICE-CONNECTED PERMANENT AND TOTAL DISABILITY RATING.
HB 5005 PA 24-8	AN ACT EXPANDING PAID SICK DAYS IN THE STATE.
HB 5219 PA 24-9	AN ACT CONCERNING STANDARDS FOR THE SPRAYING OF HERBICIDES ALONG RAILROAD RIGHT-OF-WAYS.
