# Governor's Council on Women and Girls Full Council Meeting (Virtual) Tuesday November 16, 2021 @ 3pm

### <u>Minutes</u>

- I. Greetings and Opening Remarks
  - a. Lt. Governor notes that this is the last full council meeting of the calendar year and highlights:
    - i. Women leadership panel discussions;
    - ii. Lt. Governor's computing challenge, with high participation;
    - iii. Housing and Community Development Leadership Institute;
    - iv. Increased access to health resources for new mothers; and
    - v. Panel discussion encouraging more women to express interest in serving on State Boards and Commissions, in furtherance of Council legislation.
  - b. Lt. Governor thanks Council members and acknowledges and welcomes newest member, Department of Public Health Commissioner-Designate Dr. Manisha Juthani, who will also serve as a Tri-Chair for the Health & Safety Subcommittee.
  - c. Lt. Governor asks that announcements be shared in that chat function for recirculation, noting that they may also be acknowledged (time permitting) during the announcements portion of the agenda.
- II. Report from Council Leadership (Lt. Governor Bysiewicz)
  - a. Acknowledges receipt of suggestions for potential Council legislation in the upcoming session, with respect to:
    - i. promoting financial management and debt education;
    - ii. protecting consumers from certain credit reporting that can have negative impacts on their scores; and
    - iii. increasing employment data transparency across different arms of government.
  - b. Notes that she and Sec. McCaw are considering whether some of the proposals can be taken on administratively and exploring legislative impact for others.
  - c. Thanks the financial literacy working group, Deputy Commissioner Shante Hanks and Assistant Comptroller Tara Downes for their suggestions.
  - d. Notes that January meeting should have updates on status of proposals and administrative work relevant to concepts previously submitted by Health & Safety.

      Heritage month from mid-September through mid-October; Deaf
      Awareness Month in September; and National Disability

    - 4. Closed with a presentation from Steering Committee member, Girls With Impact.
  - iv. Lt. Governor further notes that Steering Committee members should let Cherie Phoenix-Sharpe know if interested in presenting at a meeting
  - v. Lt. Governor introduces Assistant Comptroller Tara Downes.
  - vi. Assistant Comptroller Downes notes:
    - 1. Equity report presentation on state workforce was also presented to Leadership subcommittee
    - 2. Meetings have been held with other agencies that may be impacted by the recommendations
    - 3. Discussions about the report continue and feedback is welcome
  - vii. Lt. Governor introduces Deputy Housing Commissioner Shante Hanks.
  - viii. C. Phoenix-Sharpe notes that Deputy Commissioner Hanks is held up
  - ix. Lt. Governor introduces Paid Family and Medical Leave Insurance Authority CEO Andrea Barton Reeves
  - x. A. Barton Reeves Presents (see Attachment 2) and further:
    - 1. Introduces Marketing Officer Jessica Vargas who is primarily responsible for outreach and engagement
    - 2. Notes that partnership with Public School Superintendents is to reach the parents of students in public schools
    - 3. Notes that applications accepted starting December 1 are for benefits payable starting January 1

    - 2. Partnership with Neighborworks America and modifications and improvements to the web-based curriculum
    - 3. Partnership with Solutions for Community on the internship and mentorship component of curriculum
    - 4. Program is currently working with new cohort and is growing with attendees, participants, partnerships (open to more) and staff:

      - b. LISC has an RFP for more presenters and instructors
