4.	CHW Instructor Training Requirements Workgroup	Adry Sotolongo
<p>Adry Sotolongo reviewed the core curriculum that is based in the Missouri model, with several added modules such as: Trauma Informed Care and Equity and Inclusion. The workgroup met again on Tuesday, October 25 to consider what to do regarding the existing trainers. The group understood that instructors will need to go through renewals, that CHWs are certified every 3 years and that right now, instructors are required to complete 30 hours per year of professional development. Hours teaching count toward this requirement and 2 hours are set aside for Social Determinants of Health and 2 hours on Cultural Humility.</p> <p>The formal recommendations of the workgroup are:</p> <ol style="list-style-type: none"> 1. Adopt the Missouri CHW Train the Trainer model with additions as outlined in the presentation. 2. Establish a standard for all trainers of a minimum 3 years' experience as CHW or combination of experience as a CHW and background in education or health care. 3. Implement requirement of 3 hours (within the 30 hours required) of training in areas of the Train the Trainer curriculum of their choosing. 4. Grandfather current trainers <p>Laura asked a question regarding the grandfathering of the current trainers: Do they still have to meet the 30 hours of professional development, but without having to take the full Train the Trainer curriculum? The answer is yes; they will not have to go through the full training but will be given the opportunity to take the portions of the training of their choice.</p> <p>A motion was set forth to accept the above recommendations by Milagrosa Seguinot. It was seconded by Kim Barry. The motion passed unanimously.</p>
