<b>4.</b>	<b>Gateway Community College</b>	<b>Erika Lynch</b>
<p>Erika Lynch discussed Community colleges are going to be listed as one Community college and will be called CT State and will be listed as individual campuses starting around this time next year. There will be one year of consolidation and after graduation next year, Gateway Community College will become CT State at the Gateway Community College. The program for Community health workers is approved program by Gateway Community College. Moving forward there will be program alignment across the campuses. They want to start to look at all the programs and align them across all 12 campuses. The question for discussion to the group was:</p> <ul style="list-style-type: none"> <li>• Should each individual campus submit its own application to become an approved training vendor?</li> </ul> <p>We will research other states to see what they have done with their CHW training programs, do some pros and cons, and case scenarios, and give a report at next month's meeting.</p>		
<b>5.</b>	<b>CHW Instructor Requirements</b>	<b>Laura Morris</b>
<p>Laura Morris discussed the requirements for CT CHW instructor requirements along with other states researched for comparison to determine if we want to revise the CT requirements. Laura Morris opened the floor for discussion.</p> <ul style="list-style-type: none"> <li>• The body agreed a bachelor's degree or higher should not be required to become a CHW instructor.</li> <li>• Require instructor to have additional training i.e.; Train the Trainer</li> <li>• There should be some additional training on classroom management</li> </ul> <p>Will send Missouri's CHW instructor requirements to everyone to review and will discuss at next month's meeting. Would like to learn from current CT trainers what other additional training instructors need to manage classroom settings and teach in general. Milagrosa Seguinot and Melanie Alvarez volunteered to be a part of the workgroup to work on this.</p>		
<b>6.</b>	<b>Reciprocity for CHWs from other States to apply for Certification in CT</b>	<b>Laura Morris</b>
<p>Laura Morris opened the discussion for Community health workers who received training from another State wanting to know if there's reciprocity to become certified in Connecticut.</p> <ul style="list-style-type: none"> <li>• Chris Andresen, DPH stated there's nothing prohibiting somebody with no certification from doing CHW work, which is the way it's been historically done but reciprocity would mean they can get a certification in Connecticut not that they would function under in other states' certification.</li> <li>• The law that applies to CHWs states if a person moves to Connecticut and they moved to Connecticut, and they've practiced in another State for four years that would automatically qualify them for the licensure certification and Connecticut.</li> </ul>		
<b>7.</b>	<b>Review Committee Update</b>	<b>Leslie Greer</b>
<p>Leslie Greer provided an update that OHS has met with two potential training vendors last month. There has been one new user registered in the CHW training vendor portal. There is a meeting scheduled with the Review Committee on June 9<sup>th</sup> for a discussion.</p>		
<b>8.</b>	<b>Marketing and Outreach Update</b>	<b>Jennifer Behuniak, DPH</b>
<p>Laura Morris announced Elizabeth Conklin, DPH will oversee the 1815 grant and the Community health worker work. Evelyn had to leave the call early. Jennifer Behuniak provided a Marketing and Outreach update. There are radio spots going out, and several targeted ads on multiple social media platforms. Currently in the last efforts of having everything translated into Spanish to make sure we're reaching a majority of the CHWs in the state.</p>
