It is scheduled for April 6th at the LOB and it will be a full day event • Those who are not members of the association yet can become members on their website • Kim Barry indicated that they've had a preliminary meeting with the United Way to establish monthly meetings for the CHW's in New London County. She asked whether the association has an evaluation tool available that could get them the type of information that would be beneficial for them and the client. Milagrosa Seguinot indicated that there is no standard tool right now. However, many groups prepare their own assessment based on their needs. Ms. Seguinot offered to share a sample tool to be customized. 	
5.	Presentation on CHW Coalition Update	Samantha Lew, HES
	<ul style="list-style-type: none"> • Milagrosa Seguinot thanked the members of the coalition for their hard work. The Coalition was established last year. The coalition has CHW's, allies and employers. • The objectives of the coalition include: 1) establish a collaborative space for CHWs and CHW allies, 2) discussion and dialogue about the CHW workforce and 3) Co-design principles for sustainable funding in CT and advocate for implementation • The legislative language proposed includes "To require DSS to create a comprehensive community health worker reimbursement plan that meets all of the criteria laid out by the CHW coalition about the scope of work and reimbursement. • Ms. Lew shared draft outline takeaways that include minimum overarching principles and CHW services to be included, as well as funding requirements. • The coalition has established 3 sub-committees: 1) Policy, 2) Communications and 3) Stakeholder Engagement. Interested individuals are welcome to join any of these sub-committees. • Milagrosa Seguinot also invited anyone interested in testifying at public hearings. It is expected the hearings will begin in early March. Also, there is a CHW Lobby Day planned for April 6.

	<ul style="list-style-type: none"> • Milagrosa Seguinot presented the results of the 2022 Connecticut Community Health Worker Survey. <ul style="list-style-type: none"> ○ The survey goals included 1) CHW Association of CT membership awareness and interest, 2) CHW Certification awareness and perceived value, 3) Assess CHW Certification media campaign exposure, 4) Assess skills and training and 5) Perceptions of support from their organization. ○ The survey was anonymous, and it was provided in English and Spanish ○ It was completed by 213 respondents ○ The demographics breakdown included: 1) 85% identify as Female, 2) 44% identify as Hispanic or Latino, 3) 49% identify as White or Caucasian and 4) 27% identify as Black or African American. Other demographic questions included level of education, age, earnings and fluency in at least two languages. ○ The survey helped the sponsoring partners to look into many aspects of the work of
