

Connecticut Statewide Health IT Plan Strategic Focus Areas

Focus Area 1

Sustain and increase use of statewide HIE services

Focus Area 2

Implement systems to improve health equity and address health-related social needs

Focus Area 3

Improve service coordination and data sharing across state HHS agencies

Focus Area 4

Support behavioral health providers with the adoption of EHR and HIE services

Focus Area 5

Protecting individuals' health information privacy

Focus Area 6

Establish electronic data standards to facilitate development of integrated electronic health information systems



November 2021 HITAC and Subsequent Feedback

- Ensure patients' health, best interest, autonomy and control are front and center
- Consider changing the “goals” nomenclature
- Assess the opportunity costs of more workgroups and other committees, given workloads and time commitments of HITAC members
- Acknowledge that money and technical assistance alone will not create the changes we want to see – there is also a need for grassroots level culture change as part of the IT adoption process
- Ensure solid alignment between the plan and Connie's strategic vision, specifically in the context of any HIE-related recommendations
- Concerns around patient privacy in Connie, including implementation of a best possible medication history (BPMH) and areas where non-providers may access patient records
- Explore concepts of an architecture plan for Connie's potential public health use cases, including data elements and structure, data storage, and web services interfacing
